A/K2/217 Minor Relaxation of Building Height Restriction for Permitted Sports and Recreation Club in "Other Specified Uses" annotated "Sports and Recreation Club" Zone, 8 Wylie Road, Kowloon (MPC Paper No. A/K2/217)

3. The Secretary reported that Wong Pak Lam & Associates Consulting Engineers & Architects Limited (WPL) was one of the consultants of the applicant. Mr Alex T.H. Lai had declared interest on the item for his firm had business dealings with WPL.

4. The Committee noted that the applicant's representative requested on 4.10.2018 for deferment of the consideration of the application for two months in order to allow time for preparation of further information to address departmental comments. It was the first time that the applicant requested deferment of the application.

5. After deliberation, the Committee <u>decided</u> to <u>defer</u> a decision on the application as requested by the applicant pending the submission of further information from the applicant. The Committee <u>agreed</u> that the application should be submitted for its consideration within two months from the date of receipt of further information from the applicant. If the further information submitted by the applicant was not substantial and could be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The Committee also <u>agreed</u> to <u>advise</u> the applicant that two months were allowed for preparation of the submission of the further information, and no further deferment would be granted unless under very special circumstances.

A/K5/800 Proposed Shop and Services (Neighbourhood Resources Centre) in "Other Specified Uses" annotated "Business" Zone, Unit A (Portion), G/F, Wing Hong Factory Building, 777-783 Yu Chau West Street, Cheung Sha Wan, Kowloon (MPC Paper No. A/K5/800)

6. The Secretary reported that the application was submitted by the Urban Renewal Authority (URA). The application site was located in Cheung Sha Wan. The following Members had declared interests on the item :

Mr Raymond K.W. Lee - (the Chairman) <i>as the Director of Planning</i>	being a non-executive director of the URA Board and a member of the Planning, Development and Conservation Committee of URA;

Dr Lawrence W.C. Poon -	being a non-executive director of the URA Board, a member of the Lands, Rehousing and Compensation Committee and the Planning, Development and Conservation Committee, and a director of the Board of the Urban Renewal Fund of URA;
Mr Wilson Y.W. Fung] Ms Lilian S.K. Law]	being a director of the Board of the Urban Renewal Fund of URA;

Mr Stephen H.B. Yau	-	being a past member of the Wan Chai District Advisory Committee of URA;
Mr Thomas O.S. Ho	-	having current business dealings with URA;
Mr Alex T.H. Lai	-	his firm having current business dealings with URA; and
Mr Daniel K.S. Lau	-	being an ex-employee and ex-Director (Development & Marketing) of Hong Kong Housing Society which was currently in discussion with URA on housing development issues.

7. Members noted that Mr Thomas O.S. Ho had tendered apologies for not being able to attend meeting. As the interests of the Chairman, the Vice-chairman, Dr Lawrence W.C. Poon were direct, Members agreed that they should leave the meeting temporarily for the item. According to the procedure and practice adopted by the Town Planning Board, as a matter of necessity, the Chairman or the Vice-chairman should continue to assume the chairmanship. As the interest of the Vice-chairman was comparatively less direct than the Chairman, the Committee agreed that the Vice-chairman should take over the chairmanship for the item but a conscious effort should be made to contain his scope of involvement in an administrative role to minimise any risk that he might be challenged. As the interests of Messrs Stephen H.B. Yau, Wilson Y.W. Fung and Ms Lilian S.K. Law were indirect and Messrs Alex T.H. Lai and Daniel K.S. Lau had no involvement in the application, the Committee agreed that they could stay in the meeting.

[The Chairman and Dr Lawrence W.C. Poon left the meeting temporarily.]

Presentation and Question Sessions

8. With the aid of a PowerPoint presentation, Ms Katy C.W. Fung, STP/TWK, presented the application and covered the following aspects as detailed in the Paper :

- (a) background to the application;
- (b) the proposed shop and services (neighbourhood resources centre);
- (c) departmental comments departmental comments were set out in paragraph 9 of the Paper. Concerned departments had no objection to or no adverse comment on the application;
- (d) no public comment was received during the first three weeks of the statutory publication period; and
- (e) the Planning Department (PlanD)'s views PlanD had no objection to the application based on the assessment made in paragraph 11 of the Paper. The proposed development was generally in line with the planning intention of "Other Specified Uses" annotated "Business" ("OU(B)") zone and complied with the Town Planning Board Guidelines for Development within the "OU(B)" zone in that it would not induce adverse fire safety, traffic and infrastructural impacts on the development within the subject building and adjacent areas. The use of shop and services was considered not incompatible with other uses of the same industrial building including mainly industrial-related offices and warehouses on the upper floors. Relevant Government departments consulted had no adverse comment on or no objection to the application.
- 9. Members had no question on the application.

Deliberation Session

10. After deliberation, the Committee <u>decided</u> to <u>approve</u> the application, on the terms of the application as submitted to the Town Planning Board (TPB). The permission should be valid until <u>19.10.2020</u>, and after the said date, the permission should cease to have effect unless before the said date, the development permitted was commenced or the permission was renewed. The permission was subject to the following conditions :

- "(a) the provision of fire service installations and water supplies for firefighting and a means of escape separated from the industrial portion before operation of the use to the satisfaction of the Director of Fire Services or of the Town Planning Board; and
- (b) if the above planning condition is not complied with before operation of the use, the approval hereby given shall cease to have effect and shall on the same date be revoked without further notice."

11. The Committee also <u>agreed</u> to <u>advise</u> the applicant to note the advisory clauses as set out at Appendix II of the Paper.

[The Vice-chairman thanked Ms Katy C.W. Fung, STP/TWK for her attendance to answer Members' enquiries. She left the meeting at this point.]

12. The Secretary reported that the application site was located in Kowloon Tong and the application was submitted by the Leisure and Cultural Services Department (LCSD). ACLA Limited (ACLA), ESA Consulting Engineers Limited (ESA), MVA Hong Kong Limited (MVA), P & T Architects and Engineers Limited (P & T) and Gammon Construction Limited (Gammon) were five of the consultants of the applicant. The following Members had declared interests on the item:

Mr Alex T.H. Lai	-	his firm having current business dealings with LCSD, ACLA, ESA, MVA and Gammon;
Ms Jacinta K.C. Woo	-	her spouse being a Group Director of P & T;
Dr Lawrence W.C. Poon	-	working in the City University of Hong Kong and living in its quarters in Kowloon Tong; and
Mr Stanley T.S. Choi	-	his spouse being a director of a company which owns properties in Kowloon Tong.

13. The Committee noted that Mr Thomas O.S. Ho had tendered apologies for being unable to attend the meeting and the applicant had requested deferment of consideration of the application. As the interest of Ms Jacinta K.C. Woo, as Secretary, was remote, Dr Frankie W.C. Yeung, Messrs Alex T.H. Lai and Franklin Yu had no involvement in the application, the interests of Professor T.S. Liu and Mr Stanley T.S. Choi were indirect, and the quarters resided by Dr Lawrence W.C. Poon did not have a direct view of the application site, the Committee agreed that they could stay in the meeting.

14. The Committee also noted that the applicant's representative requested on 4.10.2018 for deferment of the consideration of the application for two months in order to allow time for preparation of further information to address departmental comments. It was the second time that the applicant requested deferment of the application. Since the last

deferment, the applicant had submitted further information including responses to departmental comments from the Planning Department and Environmental Protection Department.

15. After deliberation, the Committee <u>decided</u> to <u>defer</u> a decision on the application as requested by the applicant pending the submission of further information from the applicant. The Committee <u>agreed</u> that the application should be submitted for its consideration within two months from the date of receipt of further information from the applicant. If the further information submitted by the applicant was not substantial and could be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The Committee also <u>agreed</u> to <u>advise</u> the applicant that two months were allowed for preparation of the submission of the further information. Since it was the second deferment and a total of four months had been allowed for the preparation of the further information, no further deferment would be granted unless under very special circumstances.
