Lai had tendered apologies for not being able to attend the meeting, and Mr Franklin Yu and Ms Christina M. Lee had not yet arrived to join the meeting. As the item was to report the abandonment of an appeal case and no discussion was required, Members agreed that Mr Ivan C.S. Fu could stay in the meeting.
- 5. The Secretary reported that an appeal had been abandoned by the Appellant on his own accord. Town Planning Appeal No. 8/16 was received by the Appeal Board Panel (Town Planning) (TPAB) on 4.10.2016 against the decision of the Board on 22.7.2016 to reject on review an application (No. A/K1/251) for proposed minor relaxation of site coverage restriction (from 15% to 24%) for permitted 'Place of Recreation, Sports or Culture' use in "Other Specified Uses" annotated "Sports & Recreation Clubs" zone on the approved Tsim Sha Tsui Outline Zoning Plan. The minor relaxation of site coverage was approved at the s.16 stage, the review was on the approval condition.

6. The appeal was abandoned by the appellant on 13.7.2017. On 18.7.2017, TPAB formally confirmed that the appeal was abandoned in accordance with Regulation 7(1) of the Town Planning (Appeals) Regulations of the Town Planning Ordinance.
