Submission of the Draft Kai Tak Outline Zoning Plan No. S/K22/5A under Section 8 of the Town Planning Ordinance to the Chief Executive in Council for Approval (TPB Paper No. 10424)

[The item was conducted in Cantonese.]

3. The Secretary reported that the draft Kai Tak Outline Zoning Plan (OZP) No. S/K22/5 mainly involved the optimization of the development potential of residential/commercial sites in the North Apron and Runway areas of the ex-airport site, rezoning of suitable sites for residential, commercial, Government, institution or community (GIC) and open space uses, and incorporation of the latest development proposals for the area. The proposed amendments included the rezoning of sites for proposed public housing developments by the Housing Department (HD), which was the executive arm of

the Hong Kong Housing Authority (HKHA). The consultants of the Review Study of Kai Tak Development (the Review) included AECOM Asia Co. Limited (AECOM), Urbis Limited (Urbis) and Leigh & Orange Limited (L&O). One of the representation sites was related to a proposed campus development by the Vocational Training Council (VTC). The following Members had declared interests on the item for being acquainted/having affiliations/business dealings with HKHA, the consultants of the Review, the representers and commenters or their representatives including Kerry Group (Kerry), the parent company of Kerry DG Warehouse (Kowloon Bay) Limited (R11) and its representative, Llewelyn Davis Hong Kong Limited (LD); CK Hutchison Holdings Limited (CKH), the parent company of Goodwell-Fortune Property Services Limited (C309); Sandy Bay Rugby Football Club of the University of Hong Kong (HKU) (C152); Mr Paul Zimmerman of Designing Hong Kong Limited (C258); Ms Mary Mulvihill (C260 and C433); Masterplan Limited, representatives of Hong Kong Water Sports Council (R3); Hong Kong Rugby Union (R13); and VTC (R1/C263) and its consultants, Ove Arup Partners Hong Kong Limited (Arup):

- 4. Members noted that Mr H.W. Cheung, Mr Ivan C.S. Fu, Dr C.H. Hau, Mr K.K. Cheung, Mr Alex T.H. Lai, Mr Stephen L.H. Liu, Miss Winnie W.M. Ng, Mr Lincoln L.H. Huang and Mr Franklin Yu had tendered apologies for not being able to attend the meeting. As the item was procedural in nature, Members agreed that the rest of the Members who had declared interests in the item could stay in the meeting.
- 5. The Secretary briefly introduced the Paper. On 17.2.2017, the draft Kai Tak OZP No. S/K22/5 (the draft OZP) was exhibited for public inspection under section 5 of the Town Planning Ordinance (the Ordinance). A total of 12,154 representations and 1,428 comments were received. After giving consideration to the representations and comments under section 6B(1) of the Ordinance on 6.12.2017, 7.12.2017, 11.12.2017, 14.12.2017, 3.1.2018, 4.1.2018, 10.1.2018, 11.1.2018, 20.4.2018 and 8.5.2018, the Board decided not to propose any amendment to the draft OZP to meet the adverse representations, and noted the supportive views and comments of the remaining representations.
- 6. Since the representation consideration process had been completed, the draft OZP was ready for submission to the Chief Executive in Council (CE in C) for approval.
- 7. After deliberation, the Board:

- (a) <u>agreed</u> that the draft Kai Tak OZP No. S/K22/5A and its Notes at Annexes I and II of the Paper respectively were suitable for submission under section 8 of the Ordinance to the CE in C for approval;
- (b) <u>endorsed</u> the updated Explanatory Statement (ES) for the draft Kai Tak OZP No. S/K22/5A at Annex III of the Paper as an expression of the planning intention and objectives of the Board for the various land-use zonings on the draft OZP and issued under the name of the Board; and
- (c) <u>agreed</u> that the updated ES was suitable for submission to the CE in C together with the draft OZP.
