#### 1. **Background**

On 15.11.2017, the applicant seeks planning permission to use the application premises (Plan A-1) for proposed vehicle repair workshop.

1.2 On 12.1.2018, the Metro Planning Committee (the Committee) of the Town Planning Board (the Board) decided to defer a decision on the application for one month, as requested by the applicant, to allow time to prepare further information (FI) to address the comments from Transport Department.

# 2. Request for Deferment

On 28.2.2018, the applicant's agent wrote to the Secretary of the Board requesting the Board to defer making a decision on the application for one month to allow time for preparation of FI to address comments from Transport Department and Lands Department (**Appendix I**).

#### 3. Planning Department's Views

- 3.1 The Planning Department has no objection to the request for deferment as the justifications for deferment meet the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33) in that more time is required for the applicant to prepare further information in response to comments from the Transport Department and Lands Department, the deferment period is not indefinite and the deferment would not affect the interests of other relevant parties.
- 3.2 Should the Committee agree to defer making a decision on the application, the application will be submitted to the Committee for consideration within two months upon receipt of further submission from the applicant. If the further information submitted by the applicant is not substantial and can be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The applicant should be advised that the Committee has allowed a maximum period of one month for preparation of submission of FI, and no further deferment would be granted unless under very special circumstances.

#### 4. Decision Sought

The Committee is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted to the Committee for consideration at the next meeting.
