# APPLICATION FOR PERMISSION UNDER SECTION 16 OF THE TOWN PLANNING ORDINANCE

#### APPLICATION NO. A/NE-LK/115

<u>Application</u>: Proposed House (New Territories Exempted House (NTEH) - Small House)

### 1. The Proposal

- 1.1 The applicant, who claim himself an indigenous villagers of Sha Tau Kok Heung<sup>1</sup>, seek planning permission to build a NTEH (Small House) on the application site (the Site) in Ma Tseuk Leng, Sha Tau Kok (**Plans A-1** and **A-2a**). The Site falls within an area zoned "AGR" on the approved Luk Keng and Wo Hang OZP No. S/NE-LK/11. According to the Notes of the OZP, 'House (NTEH only, other than rebuilding of NTEH or replacement of existing domestic building by NTEH permitted under the covering Notes)' is a Column 2 use in "AGR" zone requiring planning permission from the Town Planning Board (the Board).
- 1.2 Details of the proposed NTEH (Small House) are as follows:

Total Floor Area : 195.09 m<sup>2</sup>

Number of Storeys : 3 Building Height : 8.23 m Roofed Over Area : 65.03 m<sup>2</sup>

1.3 The applicant indicates that the uncovered area of the Site would be used as circulation area for the proposed Small House. Layout of the proposed Small House (including

septic tank) is shown on **Drawing A-1**.

1.4 In support of the application, the applicant has submitted the Application Form with attachment (**Appendix I**) which was received by the Board on 4.9.2018.

#### 2. <u>Justifications from the Applicant</u>

The justifications put forth by the applicant in support of the application are detailed in Appendix V of the Application Form in **Appendix I**. They can be summarised as follows:

- (a) the applicant is an indigenous villagers of Sha Tau Kok Heung and is applying for Small House grant;
- (b) the Site falls within the 'Village Environs' ('VE') of Ma Tseuk Leng Village;
- (c) the applicant has no private land within the "Village Type Development" ("V") zone and the Site is the only available lot owned by the applicant for building Small Houses; and
- (d) the Small House development is not incompatible to the surrounding area and there are newly built Small Houses very close to the Site.

#### 3. Compliance with the "Owner's Consent/Notification" Requirements

The applicant is the sole "current land owner" of the lot. Detailed information would be deposited at the meeting for Members' inspection.

#### 4. Assessment Criteria

The set of Interim Criteria for Consideration of Application for New Territories Exempted House (NTEH)/Small House in New Territories (the Interim Criteria) was first promulgated on 24.11.2000 and had been amended four times on 30.3.2001, 23.8.2002, 21.3.2003 and 7.9.2007. The latest set of Interim Criteria, which was promulgated on 7.9.2007, is at **Appendix II**.

## 5. Previous Application

There is no previous application of the Site.

## 6. <u>Similar Applications</u>

- 6.1 There are 40 similar applications involving 34 sites for Small House development within/partly within the "AGR" zone in the vicinity of the Site in the Luk Keng and Wo Hang area (**Plan A-1**) since the first promulgation of the Interim Criteria on 24.11.2000.
- 6.2 Among these similar cases, 31 applications were approved by the Committee between February 2001 and January 2015 (i.e. before a more cautious approach is adopted by

- the Board) (**Plan A-1**). These applications were approved by the Committee mainly on the considerations that the application generally complied with the Interim Criteria in that more than 50% of the footprint of the proposed Small House fell within the 'VE' and there was a general shortage of land within the "V" zone at the time of consideration; the proposed Small House development was not incompatible with the surrounding rural and village environment; and the proposed development was not expected to have significant adverse impacts on the surrounding area. Two of them (i.e. Applications No. A/NE-LK/28 for one proposed Small House and No. A/NE-LK/79 for four proposed Small Houses), which located to the immediately east and west of the Site, were approved by the Committee on 21.9.2001 and 19.7.2013 respectively (**Plan A-2a**). Another five applications No. A/NE-LK/106, 107, 109, 111 and 112 (**Plan A-1**) were also approved by the Committee between December 2016 and April 2018 (i.e. after a more cautious approach is adopted by the Board) mainly for the reason of being the subject of previously approved applications (No. A/NE-LK/73, 30, 77 and 80 respectively).
- The other three applications No. A/NE-LK/78, 92 and 93 were rejected by the 6.3 Committee between March 2013 and October 2014 (i.e. before a more cautious approach is adopted by the Board) for reasons that proposed Small House was not in line with the planning intentions of "AGR" and "Green Belt" ("GB") zones; the proposed development might have adverse impact on a natural stream in the vicinity; the application did not comply with the Interim Criteria and TPB PG-No. 10 on application for development within "GB" zone in that the proposed development would involve vegetation clearance and hence affect these existing natural landscape; land was still available within the "V" zone of Ma Tseuk Leng for Small House development; and the approval of the application would set an undesirable precedent for similar applications in the area. Another application No. A/NE-LK/114, which is located to the northwest of the Sites, was rejected by the Committee in September 2018 (i.e. after a more cautious approach is adopted by the Board) mainly on the grounds that the proposed Small House was not in line with the planning intention of "AGR" zone; the application did not comply with the Interim Criteria in that the proposed development would involve vegetation clearance and hence affect the existing natural landscape and land was still available within the "V" zone of Ma Tseuk Leng, Ma Tseuk Leng San Uk Ha and Shek Kiu Tau village cluster for Small House development.
- 6.4 Details of these applications are summarised at **Appendix III** and their locations are shown on **Plan A-1**.
- 6.5 For Members' information, two other similar applications (No. A/NE-LK/116 and 117) each for one proposed house (NTEH Small House) in Ma Tseuk Leng Village (**Plan A-1**) will be considered by the Committee at the same meeting.
- 7. The Site and its Surrounding Areas (Plans A-1, A-2a and A-2b, aerial photo on Plan A-3 and site photos on Plans A-4a and A-4b)
  - 7.1 The Site is:
    - (a) mainly flat and overgrown with weeds (**Plans A-4a** and **A-4b**); and
    - (b) located in close proximity to the village cluster of Ma Tsuek Leng San Uk Ha (**Plan A-2a**).

- 7.2 The surrounding area has the following characteristics:
  - (a) to the north is the village cluster of Ma Tsuek Leng San Uk Ha within the "V" zone (**Plans A-2a** and **A-2b**);
  - (b) to the northeast are some village houses built under approved Small House Applications No. A/NE-LK/26, 28, 29 and 52, and to the east are fallow agricultural land;
  - (c) to the south are active/fallow agricultural land and the Sha Tau Kok Road Wo Hang; and
  - (d) to the west are fallow agricultural land, existing village houses, an open storage yard and the local road leading to Sha Tau Kok Road Wo Hang.

## 8. Planning Intention

The planning intention of the "AGR" zone in the Luk Keng and Wo Hang area is primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes. It is also intended to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes.

#### 9. Comments from Relevant Government Departments

9.1 The application has been assessed against the assessment criteria in **Appendix II**. The assessment is summarised in the following table:

  - (i) District Officer (North), Home Affairs Department.
- 9.3 The following Government departments have no comment on / no objection to the application:
  - (a) Chief Highway Engineer/New Territories East, Highways Department; and
  - (b) Project Manager (North), North Development Office, Civil Engineering and Development Department.

#### 10. Public Comments Received During Statutory Publication Period

On 11.9.2018, the application was published for public inspection. During the first three weeks of the statutory public inspection period, five public comments were received (**Appendix V**). A NDC member supports the application on the reason that the proposed development will provide convenience to local villagers. The Chairman of Sheung Shui District Rural Committee indicates no comment on the application. The Hong Kong Bird Watching Society, Designing Hong Kong Limited and an individual object to the application mainly on the grounds that the proposed development is not in line with the planning intention of the "AGR" zone; approval of the application would set an undesirable precedent to the future similar applications within the "AGR" zone and land is still available within the "V" zone of Ma Tseuk Leng for Small House development.

#### 11. Planning Considerations and Assessments

11.1 The Site falls entirely within an area zoned "AGR" on the OZP. The proposed Small House development is not in line with the planning intention of the "AGR" zone which is intended primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes. It is also intended to retain fallow

- arable land with good potential for rehabilitation for cultivation and other agricultural purposes. DAFC does not support the application from agriculture point of view as the Site possesses potential for agricultural rehabilitation.
- 11.2 Based on DLO/N, LandsD's records, the total number of outstanding Small House applications for Ma Tseuk Leng, Ma Tseuk Leng San Uk Ha and Shek Kiu Tau village cluster is 64 while the 10-year Small House demand forecast for the same village cluster is 495. According to the latest estimate by PlanD, a total of about 2.32 ha (equivalent to 92 Small House sites) of land are available within the "V" zone of Ma Tseuk Leng, Ma Tseuk Leng San Uk Ha and Shek Kiu Tau village cluster for Small House development (**Plan A-2b**). DLO/N, LandsD advises that the footprint of the proposed Small House falls entirely within the 'VE' of Ma Tseuk Leng, Ma Tseuk Leng San Uk Ha and Wo Tong Kong.
- 11.3 The Site is situated in an area of rural landscape character dominated by fallow/active agricultural land, tree groups, vacant/unused land, and village houses. The proposed Small House development is not incompatible with the surrounding environment (Plans A-2a and A-3). Significant adverse landscape impact arising from the proposed development is not anticipated. In this regard, CTP/UD&L, PlanD has no objection to the application from the landscape planning perspective. C for T has reservation on the application and considers that Small House development should be confined within the "V" zone as far as possible but given that the proposed development involves one Small House only, the subject application could be tolerated. Other Government departments consulted, including DEP, CE/MN of DSD and D of FS, have no adverse comment on or no objection to the application.
- 11.4 Regarding the Interim Criteria (**Appendix II**), more than 50% of the footprint of the proposed Small House falls within the 'VE' of Ma Tseuk Leng, Ma Tseuk Leng San Uk Ha and Wo Tong Kong (**Plan A-2a**). Whilst land available within the "V" zone is insufficient to fully meet the total Small House demand (in total about 14.0 ha or equivalent to 559 Small House sites), it is noted that land (about 2.32 ha or equivalent to 92 Small House sites) is still available within the "V" zone to meet the outstanding 64 Small House applications. It should be noted that the Board has adopted a more cautious approach in approving applications for Small House development in recent years. Amongst others, in considering whether there is a general shortage of land in meeting Small House demand, more weighting has been put on the number of outstanding Small House applications provided by LandsD. As such, it is considered more appropriate to concentrate the proposed Small House development within the "V" zone for more orderly development pattern, efficient use of land and provision of infrastructure and services.
- 11.5 There are 40 similar applications for Small House development within/partly within the "AGR" zone in the vicinity of the Site in the Luk Keng and Wo Hang area (**Plan A-1**). Of them, 31 applications were approved by the Committee between February 2001 and January 2015 and three applications were rejected by the Committee between March 2013 and October 2014 (i.e. before a more cautious approach is adopted by the Board). After the adoption of a more cautious approach by the Board, five applications (No. A/NE-LK/106, 107, 109, 111 and 112) were approved by the Committee between December 2016 and April 2018 mainly for the reason of being the subject of previously approved applications (No. A/NE-LK/13, 30, 77 and 80 respectively). One application (No. A/NE-LK/114) (**Plan A-2a**) which located to the northwest of the Site and not being the subject of any previously approved application was rejected by the Committee on 7.9.2018 mainly on the

- grounds that the proposed development was not in line with the planning intention and land was still available within the "V" zone for Small House development. The circumstances of the current application are similar to that rejected application.
- 11.6 Regarding the public comments objecting to application mainly on the grounds that the proposed development is not in line with the planning intention of the "AGR" zone; approval of the application would set an undesirable precedent to the future similar applications within the "AGR" zone and land is still available within the "V" zone of Ma Tseuk Leng for Small House development, Government departments' comments and planning assessments above are relevant.

#### 12. Planning Department's Views

- 12.1 Based on the assessments made in paragraph 11 and having taken into account the public comments mentioned in paragraph 10, the Planning Department does not support the application for the following reasons:
  - (a) the proposed development is not in line with the planning intention of the "AGR" zone in the Luk Keng and Wo Hang area which is primarily to retain and safeguard good quality agricultural land / farm / fish ponds for agricultural purposes and to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes. There is no strong planning justification in the submission for a departure from the planning intention; and
  - (b) land is still available within the "V" zone of Ma Tseuk Leng, Ma Tseuk Leng San Uk Ha and Shek Kiu Tau village cluster where land is primarily intended for Small House development. It is considered more appropriate to concentrate the proposed Small House development close to the existing village cluster for orderly development pattern, efficient use of land and provision of infrastructures and services.
- 12.2 Alternatively, should the Committee decide to approve the application, it is suggested that the permission shall be valid until 2.11.2022, and after the said date, the permission shall cease to have effect unless before the said date, the development permitted is commenced or the permission is renewed. The following conditions of approval and advisory clauses are also suggested for Members' reference:

## **Approval Conditions**

- (a) the provision of septic tank, as proposed by the applicant, at a location to the satisfaction of the Director of Lands or of the Town Planning Board;
- (b) the submission and implementation of drainage proposal to the satisfaction of the Director of Drainage Services or of the Town Planning Board; and
- (c) the submission and implementation of landscape proposal to the satisfaction of the Director of Planning or of the Town Planning Board.

## **Advisory Clauses**

The recommended advisory clauses are attached at **Appendix VI**.

### 13. Decision Sought

- 13.1 The Committee is invited to consider the application and decide whether to grant or refuse to grant the permission.
- 13.2 Should the Committee decide to approve the application, Members are invited to consider the approval condition(s) and advisory clause(s), if any, to be attached to the permission, and the date when the validity of the permission should expire.
- 13.3 Alternatively, should the Committee decide to reject the application, Members are invited to advise what reason(s) for rejection should be given to the applicant.
