# APPLICATION FOR PERMISSION UNDER SECTION 16 OF THE TOWN PLANNING ORDINANCE

## APPLICATION NO. A/NE-TKL/619

**Applicant**: Mr. CHAN Kam Lin represented by Mr. LIU Chi Hang, Bernard

Site : Lot 241 S.A in D.D. 79, Ping Yeung Village, Ta Kwu Ling, New Territories

Site Area : 177.8 m<sup>2</sup> (about)

<u>Lease</u>: Block Government Lease (demised for agricultural use)

**Zonings** : "Agriculture" ("AGR") (about 177.1m<sup>2</sup> or 99.6% of the site);

"Village Type Development" ("V") (about 0.7m<sup>2</sup> or 0.4% of the site);

**Application**: Proposed House (New Territories Exempted House (NTEH) - Small House)

## 1. The Proposal

- 1.1 The applicant, who claimed to be an indigenous villager of Ping Yeung of Ta Kwu Ling Heung<sup>1</sup>, seeks planning permission to build a NTEH (Small House) on the application site (the Site) in Ping Yeung, Ta Kwu Ling (**Plans A-1 and A-2a**). The Site falls within an area mostly zoned "AGR" with a very minor portion encroached onto "V" zone on the approved Ping Che and Ta Kwu Ling OZP No. S/NE-TKL/14. According to the Notes of the OZP, 'House (NTEH only, other than rebuilding of NTEH or replacement of existing domestic building by NTEH permitted under the covering Notes)' is a Column 2 use within "AGR" zone requiring planning permission from the Town Planning Board (the Board).
- 1.2 Details of the proposed NTEH (Small House) are as follows:

Total Floor Area : 195.09 m<sup>2</sup>

Number of Storeys : 3 Building Height : 8.23 m Roofed Over Area : 65.03 m<sup>2</sup>

<sup>1</sup> According to District Lands Officer/North, Lands Department (DLO/N, LandsD), the applicant has been certified by the Indigenous Inhabitants Representative in statutory declaration that the applicant is an indigenous villager of Ping Yeung in Ta Kwu Ling Heung.

- 1.3 Layout of the proposed Small House (including septic tank) is shown on **Drawing A-1**.
- 1.4 In support of the application, the applicant has submitted the Application Form with attachment (**Appendix I**) and supplementary information (**Appendix Ia**) which were received by the Board on 13.6.2019 and 21.6.2019 respectively.

# 2. <u>Justifications from the Applicant</u>

The justifications put forth by the applicant in support of the application are detailed in part 9 of the Application Form in **Appendix I** and supplementary information in **Appendix Ia**. They can be summarised as follows:

- (a) the subject site located within the village 'environs' ('VE') of Ping Yeung; and
- (b) the applicant is an indigenous villager of Ping Yeung.

## 3. Compliance with the "Owner's Consent/Notification" Requirements

The applicant is the sole "current land owner". Detailed information would be deposited at the meeting for Members' inspection.

## 4. Assessment Criteria

The set of Interim Criteria for Consideration of Application for New Territories Exempted House (NTEH)/Small House in New Territories (the Interim Criteria) was first promulgated on 24.11.2000 and had been amended four times on 30.3.2001, 23.8.2002, 21.3.2003 and 7.9.2007. The latest set of Interim Criteria, which was promulgated on 7.9.2007, is at **Appendix II**.

#### 5. Previous Application

There is no previous application for the Site.

#### 6. Similar Applications

- 6.1 There are 20 similar applications for Small House development within/partly within the "AGR" zone (**Plan A-1**) since the first promulgation of the Interim Criteria on 24.11.2000 (**Appendix II**).
- 6.2 Four applications (No. A/NE-TKL/183, 369 and 383 and 617) were rejected by the Board on review/the Committee between February 2002 and July 2019 mainly on the considerations that the proposed Small House developments did not comply with the Interim Criteria as the footprints of the proposed Small Houses fell outside/ mainly outside the "V" zone and 'VE' of a recognised village; the applications were not in line with the planning intention of the "AGR" zone; and the approval of the applications would set undesirable precedents for similar applications.

- 6.3 Ten applications were approved with conditions by the Committee of the Board between November 2001 and August 2013 (i.e. before a more cautious approach is adopted by the Board) (**Plan A-1**) mainly on the considerations that the applications complied with the Interim Criteria in that more than 50% of the footprints of the proposed Small Houses fell within the 'VE' and there was a general shortage of land in meeting the demand for Small House development in the "V" zone of the same village; the proposed Small House developments were not incompatible with the surrounding rural and village environment; and the proposed developments were not expected to have significant adverse environmental and traffic impacts on the surrounding areas.
- 6.4 Six applications (No. A/NE-TKL/543 to 546, 599 and 604) were approved by the Committee between October 2016 and December 2018 (i.e. after a more cautious approach) is adopted by the Board (**Plan A-1**) mainly on sympathetic considerations that the proposed Small Houses situated in close proximity to the sites of approved Small House applications though the land available within the "V" zone was able to meet the outstanding applications at the time of consideration; and the proposed Small Houses were sandwiched by Small House applications and considered as an infill Small House development at the fringe of the 'VE' while a new village cluster was forming in the locality.
- 6.5 Details of the similar applications are summarised at **Appendix III** and their locations are shown on **Plan A-1**.

## 7. The Site and Its Surrounding Area (Plans A-1, A-2a and A-2b, A-3 and A-4)

- 7.1 The Site is:
  - (a) currently vacant, flat and overgrown with grass;
  - (b) located to the immediate west of the "V" zone and 'VE" of Ping Yeung (**Plan** A-2a); and
  - (c) not served by any vehicular access.
- 7.2 The surrounding area has the following characteristics:
  - (a) predominantly rural in character where village houses and fallow agricultural land are found;
  - (b) to the immediate north, east and west are fallow agricultural land (**Plans A-2a and A-3**);
  - (c) to the immediate south are village houses with Small House applications approved by the Committee in 1993; and
  - (d) to the further east are village houses within the "V" zone of Ping Yeung (**Plans** A-2a and A-3).

## 8. Planning Intention

- 8.1 The planning intention of the "AGR" zone in Ping Che and Ta Kwu Ling area is to primarily retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes. It is also intended to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes.
- 8.2 The planning intention of the "V" zone in the Ping Che and Ta Kwu Ling area is to designate both existing recognized villages and areas of land considered suitable for village expansion. Land within this zone is primarily intended for development of Small Houses by indigenous villagers. It is also intended to concentrate village type development within this zone for a more orderly development pattern, efficient use of land and provision of infrastructures and services.

# 9. Comments from Relevant Government Departments

9.1 The application has been assessed against the assessment criteria in **Appendix II**. The assessment is summarised in the following table:

  - (g) Chief Town Planner/Urban Design and Landscape, Planning Department;
  - (h) Director of Fire Services; and
  - (i) District Officer (North), Home Affairs Department.
- 9.3 The following Government departments have no comment on the applications:
  - (a) Chief Highway Engineer/New Territories East, Highways Department; and
  - (b) Project Manager (North Development Office), Civil Engineering and Development Department.

#### 10. Public Comments Received During Statutory Publication Period

On 21.6.2019, the application was published for public inspection. During the statutory public inspection period, five public comments were received (**Appendix V**). The Chairman of Sheung Shui District Rural Committee indicates no comment on the application and one NDC member supports the application as it meets the needs of the villager. The Hong Kong Bird Watching Society, Designing Hong Kong Limited and one individual object to the application mainly on the grounds that the proposed development is not in line with the planning intention of "AGR" zone; the proposed development does not comply with the Interim Criteria; there is land available in "V" zone of the village; and approval of the application would encourage 'destroy first, built later' developments and set an undesirable precedent for similar applications in the area.

#### 11. Planning Considerations and Assessments

- 11.1 The Site falls within an area mostly zoned "AGR" with a very minor portion encroached onto "V" zone. The proposed Small House development is not in line with the planning intention of the "AGR" zone which is primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes. It is also intended to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes. DAFC does not support the application from the agriculture point of view as the Site possesses potential for agricultural rehabilitation.
- 11.2 Based on DLO/N, LandsD's records, the total number of outstanding Small House applications for Ping Yeung is 64 while the 10-year Small House demand forecast for the same village is 4,600. According to the latest estimate by PlanD, about 5.36 ha (equivalent to 214 Small House sites) of land are available in the "V" zone of Ping Yeung for Small House development (**Plan A-2b**). DLO/N, LandsD advises that the proposed Small House falls entirely within the 'VE' of Ping Yeung.
- 11.3 The Site is situated in an area of rural landscape character surrounded by village houses and vegetated areas, and the proposed Small House development is not incompatible with the surrounding environment (**Plans A-2a** and **A-3**). CTP/UD&L, PlanD has no objection to the application as significant adverse impact arising from the proposed use on existing landscape resources is not anticipated. C for T considers that Small House development should be confined within the "V" zone as far as possible but given that the proposed development only involves the construction of one Small House, the application could be tolerated. Other Government departments consulted, including D of FS, CE/C of WSD and CE/MN of DSD, have no adverse comment on or no objection to the application.
- Regarding the Interim Criteria (**Appendix II**), more than 50% of the footprint of the proposed Small House falls within the 'VE' of the Ping Yeung (**Plan A-2a**). While land available within the "V" zone is insufficient to fully meet the future Small House demand, it is noted that land (about 5.36 ha or equivalent to 214 Small House sites) is still available within the "V" zone to meet the 64 outstanding Small House applications. It should be noted that the Board has adopted a more cautious approach in approving applications for Small House development in recent years. Amongst others, in considering whether there is a general shortage of land in meeting Small House demand, more weighting has been put on the number of outstanding Small House applications provided by LandsD. As such, it is considered more appropriate to concentrate the proposed Small House developments within the "V" zone for more orderly development pattern, efficient use of land and provision of infrastructure and services.
- 11.5 There is no previous application for the Site. There are 3 similar applications for Small House development with/partly within the "AGR" zone in the vicinity of the Site (**Plan A-2a**). All of them were considered before the adoption of a more cautious approach by the Board. Two applications No. A/NE-TKL/269 and 294 were approved by the Committee in 2005 and 2007 respectively mainly on the considerations that the application complied with the Interim Criteria in that more than 50% of the footprint of the proposed Small House fell within the "V" and 'VE'; there was a general shortage of land in meeting the demand for Small House development in the "V" zone; and the proposed Small House developments were not incompatible with the surrounding rural and village environment. One application No. A/NE-TKL/383 for 2 houses to its south-west was rejected by the Committee in 2012 (**Plan A-2a**) mainly on the grounds that the proposed Small House developments were not in line with the planning

intention of "AGR" zone; the proposed development did not comply with the Interim Criteria that the application site and the proposed houses were entirely outside both the 'VE' and the "V" zone of recognised villages; and the approval of the application would cause adverse landscape and drainage impacts on the surrounding areas. The circumstances of the above similar applications are different from the current application.

11.6 Two supporting comments conveyed by DO(N), HAD in paragraph 9 above is noted. Regarding the adverse public comments as detailed in paragraph 10, the Government department's comments and the planning assessment above are relevant.

# 12. Planning Department's Views

- 12.1 Based on the assessments made in paragraph 11 and having taken into account the local views and public comments mentioned in paragraph 10, the Planning Department does not support the application for the following reasons:
  - (a) the proposed development is not in line with the planning intention of the "AGR" zone in the Ping Che and Ta Kwu Ling area which is primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes and to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes. There is no strong planning justification in the submission for a departure from the planning intention; and
  - (b) land is still available within the "V" zone of Ping Yeung where land is primarily intended for Small House development. It is considered more appropriate to concentrate the proposed Small House development close to the existing village cluster for orderly development pattern, efficient use of land and provision of infrastructures and services.
- 12.2 Alternatively, should the Committee decide to approve the application, it is suggested that the permission shall be valid until 2.8.2023, and after the said date, the permission shall cease to have effect unless before the said date, the development permitted is commenced or the permission is renewed. The following conditions of approval and advisory clauses are also suggested for Members' reference:

#### **Approval Conditions**

- (a) the provision of septic tank, as proposed by the applicant, at a location to the satisfaction of the Director of Lands or of the Town Planning Board; and
- (b) the submission and implementation of drainage proposal to the satisfaction of the Director of Drainage Services or of the Town Planning Board; and

#### **Advisory Clauses**

The recommended advisory clauses are attached at **Appendix VI**.

#### 13. Decision Sought

- 13.1 The Committee is invited to consider the application and decide whether to grant or refuse to grant the permission.
- 13.2 Should the Committee decide to reject the application, Members are invited to advise what reason(s) for rejection should be given to the applicant.
- 13.3 Alternatively, should the Committee decide to approve the application, Members are invited to consider the approval condition(s) and advisory clause(s), if any, to be attached to the permission, and the date when the validity of the permission should expire.
