#### 1. **The Proposals**

The applicants, who claimed to be indigenous villagers<sup>1</sup>, seek planning permissions to 1.1 build a proposed NTEH (Small House) on each of the application sites (the Sites) in Kan Tau Tsuen, Fanling (Plans A-1a and A-2a). The Sites fall within an area zoned "AGR" on the approved Lung Yeuk Tau and Kwan Tei South OZP No. S/NE-LYT/17. According to the Notes of the OZP, 'House (NTEH only, other than rebuilding of NTEH or replacement of existing domestic building by NTEH permitted under the covering Notes)' in "AGR" zone is a Column 2 use requiring planning permission from the Town Planning Board (the Board).

As advised by District Lands Officer/North, Lands Department (DLO/N, LandsD), the applicants (i) and (ii) are indigenous villagers of Fanling Village of Fanling Heung while the applicant (iii) is an indigenous villager of Hok Tau Wai of Fanling Heung. The three Small House applications were approved in-principle in January 2017 and are pending for execution.

1.2 Details of each of the three proposed NTEHs (Small Houses) are as follows:

Total Floor Area : 195.09 m<sup>2</sup>

Number of Storeys : 3 Building Height : 8.23 m Roofed Over Area : 65.03 m<sup>2</sup>

- 1.3 Layouts of the three proposed Small Houses (including septic tanks) under applications No. A/NE-LYT/700 to 702 are shown on **Drawings A-1**, **A-2** and **A-3** respectively. The applicants indicate that there is no proposed use for the uncovered areas of their proposed Small Houses.
- 1.4 The Sites are part of the subject of a previous planning application No. A/NE-LYT/434 for development of eight Small Houses. The application was approved with conditions by the Rural and New Town Planning Committee (the Committee) on 14.1.2011. The planning permission was extended once with validity up to 14.1.2019. The planning permission lapsed on 15.1.2019. Compared with the previous application, major development parameters including the layouts of the proposed Small Houses under the current applications remain unchanged (Plan A-1b). The applicants under the current applications are the same as previous approval.
- 1.5 In support of the applications, the applicants have submitted the Application Forms with attachments (**Appendices Ia to Ic**) which were received on 4.6.2019.

# 2. <u>Justifications from the Applicants</u>

The justifications put forth by the applicants in support of the applications are detailed in Part 9 of the Application Forms at **Appendices Ia to Ic** respectively. They can be summarized as follows:

- (a) the Sites were the subject of a previous planning approval (No. A/NE-LYT/434) for eight Small House developments. In view of considerable time for the processing of Small House applications, the planning permission was extended once and lapsed on 15.1.2019. As such, fresh planning applications are submitted for the consideration of the Board; and
- (b) Building Licenses were issued by DLO/N, LandsD to the applicants.

#### 3. Compliance with the "Owner's Consent/Notification" Requirements

The applicants are the "current land owners" of their respective lots. Detailed information would be deposited at the meeting for Members' inspection.

### 4. Assessment Criteria

The set of Interim Criteria for Consideration of Application for New Territories Exempted House (NTEH)/Small House in New Territories (the Interim Criteria) was first promulgated on 24.11.2000 and had been amended four times on 30.3.2001, 23.8.2002, 21.3.2003 and 7.9.2007. The latest set of Interim Criteria, which was promulgated on 7.9.2007, is at **Appendix II**.

#### 5. Previous Applications

- 5.1 The Sites are involved in part of the three previous planning applications (No. A/NE-LYT/167, 384 and 434). Applications No. A/NE-LYT/167 and 384 are for different uses submitted by different applicants.
- 5.2 Application No. A/NE-LYT/167 for temporary trailer park with ancillary structures for a period of 12 months was rejected on review by the Board on 19.3.1999 mainly on the grounds of not in line with the planning intention of the "AGR" zone; insufficient information to demonstrate that no adverse drainage impact on the surrounding areas; and setting of an undesirable precedent.
- 5.3 Application No. A/NE-LYT/384 for proposed temporary public vehicle park for private cars for a period of 2 years was rejected by the Committee on 17.4.2009 mainly on the grounds of not in line with the planning intention of the "AGR" zone; insufficient information to demonstrate that no adverse traffic impact on the surrounding areas; and setting of an undesirable precedent.
- 5.4 The last previous planning application (No. A/NE-LYT/434) for the development of eight Small Houses at a larger site was approved by the Committee with conditions on 14.1.2011. The application was approved mainly on the grounds that the application generally complied with the Interim Criteria. The planning permission was extended once with validity up to 14.1.2019 under the application No. A/NE-LYT/434-1. The planning permission lapsed on 15.1.2019. The three applicants under the current applications are the same under the previous approval. Compared with the previous application, major development parameters including the layouts of the proposed Small Houses under the current applications generally remain the same. According to DLO/N, LandsD, the Small House grants for all eight Small Houses under application No. A/NE-LYT/434 were approved in-principle in January 2017. Of them, four were executed in 2017, and remaining four including three under the current applications were pending execution.
- 5.5 Details of the previous applications are summarized at **Appendix III** and their locations are shown on **Plan A-1b**.

#### 6. Similar Applications

- 6.1 There are 96 similar applications for Small House development within / partly within the "AGR" zone in the vicinity of the Site in the Lung Yeuk Tau and Kwan Tei South area (**Plan A-1a**) since the first promulgation of the Interim Criteria on 24.11.2000.
- 6.2 Of 85 approved applications, 53 applications were approved with conditions by the Committee between March 2001 and January 2015 (i.e. before a more cautious approach is adopted by the Board) (**Plan A-1a**) mainly on the considerations that the applications generally complied with the Interim Criteria in that more than 50% of the footprints of the proposed Small Houses fell within the 'VE' and there was a general shortage of land within the "V" zone of the same village in meeting the Small House demand; the proposed developments were not expected to have significant adverse traffic, drainage, environmental or landscape impacts on the surrounding area. The remaining 32 applications were approved between December 2015 and April 2019 (i.e. after a more cautious approach is adopted by the Board) (**Plan A-1a**) mainly for reasons of being the subject of previously approved application; being situated in close proximity to existing village houses, the implementation of new Small House under construction and approved

Small House development nearby was forming a new village cluster in the locality, and the processing of Small House grant was already at an advance stage.

- 6.3 The other 11 applications were rejected by the Committee or the Board on review between September 2003 and July 2019 mainly on the considerations that the proposed Small House developments did not comply with the Interim Criteria as the footprints of the proposed Small Houses fell mainly/entirely outside the "V" zone and the 'VE' of a recognized village; the proposed developments were not in line with the planning intention of the "AGR" zone; land was still available within the "V" zone; and approval of the applications would set undesirable precedents for similar applications.
- 6.4 Details of these applications are summarized at **Appendix IV** and their locations are shown on **Plan A-1a**.

# 7. The Sites and Their Surrounding Areas (Plans A-1a, A-2a and aerial photo on Plan A-3 and site photos on Plans A-4a to A-4b)

- 7.1 The Sites are:
  - (a) flat and vacant land with wild grass (Plan A-3);
  - (b) located in close proximity to the village cluster of Kan Tau Tsuen; and
  - (c) accessible via Sha Tau Kok Road Ma Mei Ha.
- 7.2 The surrounding areas have the following characteristics:
  - (a) to the immediate north is a piece of vacant land with grass and to its further north across Sha Tau Kok Road Ma Mei Ha is the "V" zone of Leng Tsai Tsuen;
  - (b) to the immediate west are sites of planning applications No. A/NE-LYT/679 to 681, 687 and 688 for Small House developments approved by the Committee in 2018 and 2019 (**Plan A-2a**);
  - (c) to the immediate east is site of planning application No. A/NE-LYT/354 for Small House developments approved by the Committee in 2007, and to its further east are village houses in "V" zone and the village proper of Kan Tau Tsuen (**Plan A-2a**); and
  - (d) to the south are village houses in "V" zone of Kan Tau Tsuen.

# 8. Planning Intention

The planning intention of the "AGR" zone in the Lung Yeuk Tau and Kwan Tei South area is intended primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes. It is also intended to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes.

# 9. Comments from Relevant Government Departments

9.1 The applications have been assessed against the assessment criteria in **Appendix II**. The assessment is summarised in the following table:

Among the 66 outstanding Small House applications, 10 of them fall within the "V" zone and 56 straddle or outside the "V" zone. For those 56 applications straddling or being outside the "V" zone, 28 of them have obtained valid planning approval from the Board.

  - (d) Chief Town Planner/Urban Design and Landscape, Planning Department;
  - (e) Chief Engineer/Mainland North, Drainage Services Department;
  - (f) Director of Fire Services;
  - (g) Chief Engineer/Construction, Water Supplies Department;
  - (h) Director of Agriculture, Fisheries and Conservation; and
  - (i) District Officer (North), Home Affairs Department.
- 9.3 The following Government departments have no comment on the application:
  - (a) Chief Highway Engineer/New Territories East, Highways Department; and
  - (b) Project Manager (North), North Development Office, Civil Engineering and Development Department.

#### 10. Public Comments Received During Statutory Publication Period

On 11.6. 2019, the applications were published for public inspection. During the first three weeks of the statutory public inspection period, two public comments from the Chairman of Sheung Shui District Rural Committee and an individual were received for each of the application (**Appendix VI**). The Chairman of Sheung Shui District Rural Committee indicates no comment on the applications. An individual objects to the applications mainly on the grounds that the applicants should demonstrate that the proposed development would not cause an increase in flooding susceptibility of the adjacent area.

#### 11. Planning Considerations and Assessments

- 11.1 The applications for Small House development in "AGR" zone are not in line with the planning intention of the "AGR" zone which is intended to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes and to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes. DAFC does not support the applications from the agriculture point of view as the Sites possess potential for agricultural rehabilitation.
- 11.2 Based on DLO/N, LandsD's records, the total number of outstanding Small House applications for Kan Tau Tsuen is 66 while the 10-year Small House demand forecast

for the same village is 96. According to the latest estimate by PlanD, about 2.05 ha (equivalent to 82 Small House sites) of land are available in the "V" zone of Kan Tau Tsuen for Small House development (**Plan A-2b**). DLO/N, LandsD advises that the Sites fall within the 'VE' of Kan Tau Tsuen.

- The Sites are flat and covered with grass (Plans A-3 and A-4a to A-4b). They are located to the northwest of the "V" zone and village proper of Kan Tau Tsuen, which are bounded by the existing cluster of village houses and Small House applications in the west, southwest and east of the Sites approved at different stages of development nearby. The implementation of which are forming a new village cluster in the vicinity of the Sites (Plan A-2a). The proposed Small Houses are not incompatible with the surrounding rural setting comprising village houses and fallow agricultural land. Significant adverse impact on existing landscape resources arising from the applications is not anticipated. In this regard, CTP/UD&L, PlanD has no objection to the applications from the landscape planning perspective. C for T has reservation on the applications and considers that Small House developments should be confined within the "V" zone as far as possible but given that the proposed development involves three Small Houses, they could be tolerated. Other relevant Government departments, including DEP, CE/MN of DSD and D of FS, have no adverse comment or no objection to the applications.
- 11.4 Regarding the Interim Criteria (Appendix II), more than 50% of the footprints of the proposed Small Houses fall within the 'VE' of Kan Tau Tsuen (Plan A-2a). While land available within the "V" zone is insufficient to fully meet the future Small House demand, it is noted that land (about 2.05 ha or equivalent to 82 Small House sites) is still available within the "V" zone to meeting the outstanding 66 Small House applications. It should be noted that the Board has adopted a more cautious approach in approving applications for Small House development in recent years. Amongst others, in considering whether there is a general shortage of land in meeting Small House demand, more weighting has been put on the number of outstanding Small House applications provided by LandsD. As such, it is considered more appropriate to concentrate the proposed Small House developments within the "V" zone for more orderly development pattern, efficient use of land and provision of infrastructure and services. Nevertheless, it is noted that the Sites are the subject of a previously approved planning application (No. A/NE-LYT/434) for eight Small Houses approved by the Committee in 2011 submitted by the same applicants as the current applications. As advised by DLO/N, LandsD, the Small House grants were approved in-principle pending execution. As such, sympathetic consideration might be given to the applicants.
- 11.5 There are 16 similar applications for Small House developments in the vicinity of the Site (i.e. applications No. A/NE-LYT/216, 234, 245, 246, 299, 351, 354, 389, 410, 679 to 681, 687, 688, 695 and 697) as shown on **Plan A-2a**. Of them, 9 applications (No. A/NE-LYT/216, 234, 245, 246, 299, 351, 354, 389, 410) were approved with conditions by the Committee between March 2001 and August 2010 (i.e. before a more cautious approach is adopted by the Board) (**Plan A-2a**) mainly on the considerations that the applications generally complied with the Interim Criteria in that more than 50% of the footprints of the proposed Small Houses fell within the 'VE' and there was a general shortage of land within the "V" zone of the same village in meeting the Small House demand at the time of consideration. Five other applications (No. A/NE-LYT/679 to 681, 687 and 688) were approved by the Committee between December 2018 and April 2019 (i.e. after a more cautious approach is adopted by the Board) (**Plan A-2a**) mainly on sympathetic consideration that the processing of Small House grants was already at an

advance stage. The remaining 2 similar applications No. A/NE-LYT/695 and 697 to the east of the Sites were rejected by the Committee in July 2019 (**Plan A-2a**) mainly on the grounds that land was still available within the "V" zone and they were considered more appropriate to concentrate Small House development within the "V" zone. It is considered that the circumstances of the current applications are more similar to those approved similar applications No. A/NE-LYT/679 to 681, 687 and 688.

11.6 One supporting local comment conveyed by DO(N), HAD in paragraph 9 above is noted. As for the adverse public comment objecting to the applications mainly on the grounds of adverse impact in relation to flooding susceptibility of the adjacent area as detailed in paragraph 10 above, Government departments' comments and planning assessments above are relevant.

#### 12. Planning Department's Views

- 12.1 Based on the assessments made in paragraph 11 and having taken into account the public comments mentioned in paragraph 10, the Planning Department <u>has no objection</u> to the applications.
- 12.2 Should the Committee decide to approve the applications, it is suggested that each of the permissions shall be valid until 2.8.2023, and after the said date, the permission shall cease to have effect unless before the said date, the development permitted is commenced or the permission is renewed. The following conditions of approval and advisory clauses are also suggested for Members' reference:

# **Approval Conditions**

- (a) the provision of septic tank, as proposed by the applicant, at a location to the satisfaction of the Director of Lands or of the Town Planning Board; and
- (b) the submission and implementation of drainage proposal to the satisfaction of the Director of Drainage Services or of the Town Planning Board.

#### **Advisory Clauses**

The recommended advisory clauses are attached at **Appendix VII**.

- 12.3 Alternatively, should the Committee decide to reject the applications, the following reasons for rejection are suggested for Members' reference:
  - (a) the proposed development is not in line with the planning intention of the "AGR" zone in the Lung Yeuk Tau and Kwan Tei South area which is primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes and to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes. There is no strong planning justification in the submission for a departure from the planning intention; and
  - (b) land is still available within the "V" zone of Kan Tau Tsuen which is primarily intended for Small House development. It is considered more appropriate to concentrate the proposed Small House development within the "V" zone for more orderly development pattern, efficient use of land and provision of infrastructures

and services.

# 13. Decision Sought

- 13.1 The Committee is invited to consider the applications and decide whether to grant or refuse to grant the permission.
- 13.2 Should the Committee decide to approve the applications, Members are invited to consider the approval condition(s) and advisory clause(s), if any, to be attached to the permission, and the date when the validity of the permission should expire.
- 13.3 Alternatively, should the Committee decide to reject the applications, Members are invited to advise what reason(s) for rejection should be given to the applicants.
