- (1) Submission and/or implementation of landscape and/or tree preservation proposals.
- (2) Submission of drainage proposal and/or implementation/provision of drainage proposal/facilities.
- (3) Submission and/or implementation of water supplies for firefighting/fire service installations/emergency vehicular access proposal(s)/provision of a 9-litre water type/3kg dry powder fire extinguisher.
- (4) Revocation of planning approval for non-compliance with conditions by a specified date/at any time during the approval period.
- (5) Reinstatement of the application site upon expiry of planning permission.
- (6) No operation during specific time limit is allowed on the site.
- (7) No operation is allowed on Sundays and public holidays.
- (8) No vehicles over 5.5 tonnes/heavy goods vehicles (i.e. over 24 tonnes) are allowed to be used, parked/stored on the Site.
- (9) No grinding/polishing/cutting/repairing/dismantling/workshop activities are allowed in the open area or outside the specified structure of the Site.
- (10) Posting of a notice at a prominent location of the site to indicate that no medium or heavy goods vehicle including container trailer/tractor is allowed to be parked/stored on the Site.

**Approval Condition(s):**

- (1) Submission and/or implementation of (accepted) landscape and/or tree preservation proposals.
- (2) Paving and/or fencing of the application site.
- (3) Submission of (revised) drainage proposals and/or provision/implementation of (accepted) drainage facilities/proposal.
- (4) Submission and/or implementation of (accepted) water supplies for firefighting/fire service installations/emergency vehicular access proposal(s)/provision of a 9-litre water type/3kg dry powder fire extinguisher.
- (5) Revocation of planning approval for non-compliance with conditions by a specified date/at any time during the approval period.
- (6) Reinstatement of the application site upon expiry of planning permission.
- (7) No open storage is allowed on the site.
- (8) No (night-time) operation during specific time limit is allowed on the site.
- (9) Submission and implementation of run-in/out proposal.
- (10) No car beauty/car washing/repairing/dismantling/breaking/fixing/maintenance/cleansing/paint-spraying/recycling/packaging workshop activities are allowed on the site.

**Rejection Reason(s):**

- (1) No/insufficient information in the submission to demonstrate that the development would not generate adverse environmental impact.
- (2) No/insufficient information in the submission to demonstrate that the development would not generate adverse drainage impact.
- (3) No/insufficient information in the submission to demonstrate that the development would not generate fire safety impact.
- (4) The application involves previously revoked planning permissions due to non-compliance with the approval conditions. Approval of the application with repeated non-compliances would set an undesirable precedent for other similar planning permissions for temporary uses, nullifying statutory planning control.

**Advisory clauses**

- (a) prior planning permission should have been obtained before commencing the applied use at the application site (the Site);
- (b) the planning permission is given to the development/uses under application. It does not condone any other development/use (i.e. workshop uses) which currently exists on the Site but not covered by the application. The applicant shall be requested to take immediate action to discontinue such development/use not covered by the permission;
- (c) to resolve any land issues relating to the development with the concerned owner(s) of the Site;
- (d) shorter compliance period is imposed in order to monitor the progress of compliance with approval conditions. Should the applicant fail to comply with any of the approval conditions again resulting in the revocation of planning permission, sympathetic consideration may not be given to any further applications;
- (e) to note the comments of the District Lands Officer/Yuen Long, Lands Department (DLO/YL, LandsD) that the Site comprises Old Schedule Agricultural Lots held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government. Lots 980, 981, 993 and 999 all in D.D. 119 are covered by Short Term Waivers (STWs) Nos. 3465, 3467 and 3468 which permit the structures erected thereon for the purposes of 'Warehouse and Open Storage of Exhibition Materials, Marble, Garments, Construction Materials and Vehicle Parts'. The Site is accessible from Kung Um Road via government land (GL). Her office does not provide maintenance work for GL involved and does not guarantee any right-of-way over the GL to the Site. The STW holder(s) will need to apply to her office for modification of the STW conditions where appropriate. Besides, given the proposed use is temporary in nature, only application for regularization or erection of temporary structure(s) will be considered. No construction of New Territories Exempted Building(s) will be considered or allowed. Applications for any of the above will be considered by her department acting in the capacity of the landlord or lessor at its sole discretion and there is no guarantee that such application will be approved. If such application(s) is approved, it will be subject to such terms and conditions, including among others the payment of premium or fee, as may be imposed by her department;
- (f) to note the comments of the Commissioner for Transport that the land status of the access road/path/track leading to the Site from Kung Um Road shall be checked with the lands authority. The management and maintenance responsibilities of the access road/path/track shall be clarified and consulted with the relevant management and maintenance authorities accordingly. The applicant is reminded that sufficient space should be provided within the Site for manoeuvring of vehicles. In addition, no parking, queuing and reverse movement of vehicles on public road are allowed;
- (g) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department that adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to nearby public roads/drains. His department shall not be responsible for the maintenance of any access connecting the Site and Kung Um Road;
- (h) to the comments of the Director of Environmental Protection that regarding the proposed storage of electronic parts, according to the information provided by the applicant, the Site is

hard-paved in concrete and the development is intended for storage only and no dismantling or workshop activity will be taken place at the site. The above measures as proposed by the applicant are essential and should be implemented in preventing land contamination. The applicant is advised to follow the relevant mitigation measures and requirements in the latest "Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites" issued by the Environmental Protection Department. The applicant is reminded that it is his obligation of the compliance with all relevant environmental pollution control ordinance and to apply for the licence/ permit for disposal of e-waste as defined under the Waste Disposal Ordinance as necessary;

- (i) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department that the applicant should implement the drainage facilities on site in accordance with the agreed drainage proposal. The applicant is required to rectify the drainage system if they are found to be inadequate or ineffective during operation. The applicant shall also be liable for and shall indemnify claims and demands arising out of damage or nuisance caused by a failure of the drainage system. The proposed development would neither obstruct overland flow nor adversely affected any existing natural streams, village drains, ditches and the adjacent areas. The applicant should consult DLO/YL and seek consent from relevant lot owners for any works to be carried out outside his lot boundary before commencement of the drainage works;
- (j) to note the comments of the Director of Fire Services (D of FS) on the submitted fire service installations (FSIs) proposal (**Drawing A-5** of this RNTPC Paper) that source of secondary electrical supply shall be provided; and there shall be sufficient hose reels to ensure that every part of the building (Structure 1) can be reached by a length of not more than 30m of hose reel tubing. To note the other comments of the D of FS that in consideration of the design/nature of the proposal, FSIs are anticipated to be required. The applicant is advised to submit relevant layout plans incorporated with the proposed FSIs to his department for approval. The layout plans should be drawn to scale and depicted with dimensions and nature of occupancy and the location of where the proposed FSIs to be installed should also be clearly marked on the layout plans. The applicant is also reminded that if the proposed structure(s) is required to comply with Buildings Ordinance (BO) (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans; and
- (k) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (BD) that if the existing structures (not being a New Territories Exempted House) are erected on leased land without the approval of his department, they are unauthorized building works (UBW) under the BO and should not be designated for any proposed use under the application. For UBW erected on leased land, enforcement action may be taken by the BD to effect their removal in accordance with BD's enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO. Before any new building works (including containers/open sheds as temporary buildings and land filling) are to be carried out on the Site, prior approval and consent of his department should be obtained, otherwise they are UBW. An Authorized Person should be appointed as the co-ordinator for the proposed building works in accordance with the BO. The Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5 and 41D of the Building (Planning) Regulations respectively. If the Site does not abut on a specified street of not less than 4.5m wide, its permitted development intensity shall be determined under Regulation 19(3) of the Building (Planning) Regulation at the building plan submission stage.
