#### 1. The Proposal

- 1.1 The applicant seeks planning permission to use the application site (the Site) for temporary warehouse for storage of construction materials for a period of 3 years (**Plan A-1a**). According to the Notes of the OZP for "U" zone, all uses or development except those specified in the Notes require permission from the Town Planning Board (the Board). The Site is currently occupied by the applied use without valid planning permission (**Plans A-2, A-4a** and **A-4b**).
- 1.2 The Site was involved in six previous applications (No. A/YL-TYST/450, 580, 583, 691, 719 and 796) for temporary warehouse of various items (**Plan A-1b**), which were approved with conditions each for a period of 3 years by the Rural and New Town Planning Committee (the Committee) of the Board on 18.9.2009, 30.3.2012, 20.4.2012, 22.8.2014, 27.3.2015 and 15.7.2016 respectively. All the approval conditions under the last application had been complied with and the planning permission had lapsed on 16.7.2019. Details of the previous applications are summarised in paragraph 5 below and **Appendix II**. Compared with the last application (No. A/YL-TYST/796), the current application is submitted by the same applicant for the same warehouse use with a slightly different site layout and development parameters (due to the incorporation of fire service installations (FSIs) (i.e. water tank and pump room) in the current proposal) on the same site.

- 1.3 According to the applicant, the construction materials being stored are mainly drain pipes, tiles, marble, and metal pipes. Also, no repairing, dismantling, spraying, cleaning, other workshop activities and handling of electrical appliances and computer/electronic parts (including cathode-ray tubes) will be carried out at the Site. The applicant also undertakes that all existing trees/drainage facilities within the Site will be preserved/maintained at his own expense. Furthermore, all loading/unloading activities will be carried out within the Site and no vehicle exceeding 5.5 tonnes, including medium and heavy goods vehicle, container trailers and tractors, will be allowed to enter the Site. Plans showing the vehicular access leading to the Site, site layout, landscape and tree preservation proposal and as-built drainage proposal submitted by the applicant are at **Drawings A-1** to **A-4** respectively.
- 1.4 The major development parameters of the previously approved application and the current application are summarised as follows:

# 2. Justifications from the Applicant

The justifications put forth by the applicant in support of the application are detailed in Section 3 of Supplementary Planning Statement (**Appendix Ia**). They can be summarised as follows:

- (a) The Site is subject to previous planning permissions. The applied use of the current application remains the same from the last previous application No. A/YL-TYST/796. All planning conditions imposed to the last application have been complied with. There is no material change in planning circumstances since the last approval.
- (b) According to the Town Planning Board Guidelines for "Application for Open Storage and Port Back-up Uses" (TPB PG-No.13E), the Site falls within Category 1 areas and is considered suitable for open storage and port back-up uses. The proposed development would not generate queuing of traffic outside the Site.
- (c) The proposed development is in line with the planning intention of the "U" zone. A number of open storage yards and warehouses have been approved by the Board in the vicinity of the Site. Therefore, the development is compatible with the surrounding environment. Besides, there is a shortage of land for open storage purpose in Tong Yan San Tsuen.
- (d) There will be minimal traffic, environmental, visual and drainage impacts arising from the proposal. The proposed development involves only storage of construction materials which is a clean, tidy and non-polluting use. The applicant undertakes to follow the environmental mitigation measures in the 'Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Use' (Code of Practice), where applicable.

#### 3. Compliance with the "Owner's Consent/Notification" Requirements

The applicant is not a "current land owner" but has complied with the requirements as set out in the Town Planning Board Guidelines on Satisfying the "Owner's Consent/Notification" Requirements under Sections 12A and 16 of the Town Planning Ordinance (TPB PG-No. 31A) by posting a notice of the application outside the Site and sending the notice to the Shap Pat Heung Rural Committee by registered post. Detailed information would be deposited at the meeting for Members' inspection.

# 4. Background

The Site is currently not subject to planning enforcement action.

## 5. Previous Applications

5.1 The Site was the subject of 6 previous applications (No. A/YL-TYST/450, 580, 583, 691, 719 and 796) for temporary warehouse for a variety of items (including construction materials or metal ware, machinery and spares parts, exhibition

- materials, sanitary ware and/or furniture) covering different extent of the Site. Details of the applications are summarised in **Appendix II** and the boundaries of the sites are shown on **Plan A-1b**.
- Applications No. A/YL-TYST/450, 580, 583, 691 and 719 were approved with conditions each for a period of 3 years by the Committee on 18.9.2009, 30.3.2012, 20.4.2012, 22.8.2014 and 27.3.2015 respectively, mainly on the considerations that the development was not incompatible with the surrounding areas; and departmental concerns could be addressed by imposing approval conditions. However, all five planning permissions were revoked on 18.10.2011, 30.8.2013, 20.12.2013, 22.8.2015 and 27.9.2016 respectively due to non-compliance with approval conditions.
- 5.3 The last application (No. A/YL-TYST/796) for the same applied use as the current application covering the same Site was approved with conditions for a period of 3 years by the Committee on 15.7.2016 on similar consideration as those stated above. All the approval conditions had been complied with and the planning permission had lapsed on 16.7.2019.
- 5.4 Compared with the last application, the current application is submitted by the same applicant for the same warehouse use with a slightly different site layout and development parameters (due to the incorporation of FSIs (i.e. water tank and pump room) in the current proposal) on the same site.

## 6. <u>Similar Applications</u>

- A total of 104 similar applications for various types of temporary warehouse with/without open storage and/or ancillary workshop/site office uses in this part of the "U" zone had been considered by the Committee since the promulgation of TPB PG-No. 13E on 17.10.2008. Details of the applications are summarised in **Appendix III** and the locations of the sites are shown on **Plan A-1a**.
- Out of the 104 similar applications, 100 of which were approved mainly on similar considerations that the developments were not incompatible with the surrounding open storage/warehouse uses and the concerns of relevant departments could be addressed by imposing approval conditions. However, amongst these approved applications, 33 were revoked due to non-compliance with approval conditions.
- 6.3 The remaining four applications (No. A/YL-TYST/478, 922, 926 and 943) were either rejected by the Board on review or by the Committee on 22.10.2010, 2.11.2018, 7.12.2018 and 1.2.2019 respectively, mainly on the grounds, amongst others, that approval of application with repeated non-compliances would set an undesirable precedent for other similar planning permissions for temporary uses, thus nullifying the statutory planning control system.
- 6.4 For Members' information, application No. A/YL-TYST/969 for proposed temporary warehouses for storage of stage equipment and application No. A/YL-TYST/971 for temporary warehouse for storage of paper products and electronic goods at the further north part and within the same part of the "U" zone on the OZP respectively will also be considered at this meeting (**Plan A-1a**).

# 7. The Site and Its Surrounding Areas (Plans A-1a to A-4b)

- 7.1 The Site is:
  - (a) accessible via a local track leading from Kung Um Road to its west (**Drawing A-1** and **Plan A-3**);
  - (b) paved, fenced off and largely covered by structures; and
  - (c) currently occupied by the applied use without valid planning permission.
- 7.2 The surrounding areas have the following characteristics (**Plan A-2**):
  - (a) comprise predominately warehouses intermixed with open storage/storage yards, vehicle repair workshops, a workshop, parking of vehicle and residential structure;
  - (b) there is one residential structure nearby located about 50m to its northwest;
  - (c) three warehouses with/without open storage yards and ancillary site office are located to the south, southeast and north of the Site, which are operating with valid planning permissions under applications No. A/YL-TYST/806, 904 and 941 respectively; and
  - (d) the other warehouses, open storage/storage yards, parking of vehicles, workshop and vehicle repair workshops and a workshop in the vicinity are suspected unauthorised developments (UD) subject to enforcement action taken by the Planning Authority.

# 8. Planning Intention

The planning intention of the "U" zone is to cater for the continuing demand for open storage, which cannot be accommodated in conventional godown premises. However, Kung Um Road is insufficient to cater for the heavy goods vehicular traffic generated from the proposed development. The area is therefore zoned "U" pending further detailed studies on the infrastructural impacts and the preparation of detailed layout plan.

# 9. Comments from Relevant Government Departments

9.1 The following government departments have been consulted and their views on the application are summarised as follows:

#### **Land Administration**

- 9.1.1 Comments of the District Lands Officer/Yuen Long, Lands Department (DLO/YL, LandsD):
  - (a) The Site comprises Old Schedule Agricultural Lots held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government.

- (b) Within the Site, Lots 1255, 1256, 1258 and 1259 in D.D. 119 are covered by Short Term Waivers (STW) No. 4289, 4290, 4291 and 4292 respectively to permit structure(s) erected thereon for the purpose of 'temporary warehouse for storage of construction material, exhibition material and furniture'.
- (c) The Site is accessible from Kung Um Road via Government land (GL) and private land. Her office does not provide maintenance work for GL involved and does not guarantee any right-of-way over the GL to the Site.
- (d) The Site does not fall within the Shek Kong Airfield Height Restriction Area.
- (e) Should planning approval be given to the application, the STW holder(s) will need to apply to her office for modification of the STW conditions where appropriate. Besides, given the proposed use is temporary in nature, only application for regularisation or erection of temporary structure(s) will be considered. No construction of New Territories Exempted Building(s) will be considered or allowed. Applications for any of the above will be considered by her department acting in the capacity of the landlord or lessor at its sole discretion and there is no guarantee that such application will be approved. If such application is approved, it will be subject to such terms and conditions, including among others the payment of premium or fee, as may be imposed by her department.

#### **Traffic**

- 9.1.2 Comments of the Commissioner for Transport (C for T):
  - (a) The land status of the access road/path/track leading to the Site from Kung Um Road shall be checked with the lands authority.
  - (b) The management and maintenance responsibilities of the access road/path/track shall be clarified and consulted with the relevant management and maintenance authorities accordingly.
  - (c) The applicant is reminded that sufficient space should be provided within the Site for manoeuvring of vehicles. In addition, no parking, queuing and reverse movement of vehicles on public road are allowed.
- 9.1.3 Comments of the Chief Highway Engineer/New Territories West, Highways Department (CHE/NTW, HyD):
  - (a) Adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to nearby public roads/drains.
  - (b) His department shall not be responsible for the maintenance of any access connecting the Site and Kung Um Road.

## **Environment**

- 9.1.4 Comments of the Director of Environmental Protection (DEP):
  - (a) There was no substantiated environmental complaint concerning the Site received in the past three years.
  - (b) Should the planning application be approved, the applicant should be advised to follow the relevant mitigation measures and requirements in the latest Code of Practice to minimise any potential environmental nuisances.

## **Drainage**

- 9.1.5 Comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):
  - (a) Based on the drainage proposal/planning statement enclosed in the application (**Drawing A-4**), apparently the applicant would maintain the same drainage facilities as those implemented under previous planning application No. A/YL-TYST/796.
  - (b) He has no objection in principle to the proposed development. Should the Board consider that the application is acceptable from the planning point of view, approval conditions requiring the maintenance of the existing drainage facilities implemented under application No. A/YL-TYST/796 and submission of condition record of the existing drainage facilities on site to the satisfaction of the Director of Drainage Services or of the Board should be stipulated.

#### **Fire Safety**

- 9.1.6 Comments of the Director of Fire Services (D of FS):
  - (a) He has no objection in principle to the application subject to FSIs being provided to his satisfaction.
  - (b) In consideration of the design/nature of the proposal, FSIs are anticipated to be required. Therefore, the applicant is advised to submit relevant layout plans incorporated with the proposed FSIs to his department for approval. In addition, the applicant should be advised on the following points:
    - (i) The layout plans should be drawn to scale and depicted with dimensions and nature of occupancy.
    - (ii) The location of where the proposed FSIs to be installed should be clearly marked on the layout plans.
  - (c) However, the applicant is reminded that if the proposed structure(s) is required to comply with the Buildings Ordinance (BO) (Cap. 123), detailed fire service requirements will be

formulated upon receipt of formal submission of general building plans.

#### **Building Matters**

- 9.1.7 Comments of the Chief Building Surveyor/New Territories West, Buildings Department (CBS/NTW, BD):
  - (a) As there is no record of approval by the Building Authority for the existing structures at the Site, he is not in a position to offer comments on their suitability for the use proposed in the application.
  - (b) The applicant's attention is drawn to the following points:
    - (i) If the existing structures (not being a New Territories Exempted House) are erected on leased land without the approval of BD, they are unauthorised building works (UBW) under the BO and should not be designated for any proposed use under the application.
    - (ii) For UBW erected on leased land, enforcement action may be taken by the BD to effect their removal in accordance with BD's enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO.
    - (iii) Before building works (including any new buildings, containers/open sheds as temporary demolition and land filling) are to be carried out on the Site, prior approval and consent of BD should be obtained, otherwise they are UBW. An Authorised Person should be appointed as the co-ordinator for the proposed building works in accordance with the BO.
    - (iv) The Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5 and 41D of the Building (Planning) Regulations (B(P)R) respectively.
    - (v) If the Site does not abut on a specified street of not less than 4.5m wide, its permitted development intensity shall be determined under Regulation 19(3) of the B(P)R at the building plan submission stage.

#### **Others**

9.1.8 Comments of the Chief Engineer/Cross-Boundary Infrastructure and Development, Planning Department (CE/CID, PlanD):

- (a) The Civil Engineering and Development Department (CEDD) and PlanD jointly commissioned the "Planning and Engineering Study for Housing Sites in Yuen Long South (YLS) Investigation". According to the Recommended Outline Development Plan (RODP) of YLS promulgated on 8.8.2017, the Site falls within an area zoned as "Residential Zone 2 (Subsidised Sale Flats with Commercial)" ("R2(SSF)c"), "Amenity" ("A") and an area shown as 'Road'.
- (b) The objective of YLS is to transform the degraded rural land predominantly occupied by brownfield operations including open storage yards, warehouses and rural industrial uses into housing and other uses with supporting infrastructure and community facilities, and to improve the existing environment. It is noted that the application is for temporary use for a period of 3 years. In considering the application for temporary uses, due consideration should be given on the possible implication on land clearance which would affect the future implementation of YLS.
- 9.1.9 Comments of Project Manager (West), Civil Engineering and Development Department (PM(W), CEDD):
  - (a) He has no objection to the subject application.
  - (b) However, the Site falls within the boundary of the proposed YLS Development Stage 3. The YLS Development would provide land to meet the medium to long term housing needs of Hong Kong and its detailed implementation programme with phasing and packaging of works for YLS Development is being formulated.

#### **District Officer's Comments**

9.1.10 Comments of the District Officer (Yuen Long), Home Affairs Department (DO(YL), HAD):

His office has not received any locals' comment and he has no comment from departmental point of view.

- 9.2 The following government departments have no comment on the application:
  - (a) Director of Agriculture, Fisheries and Conservation (DAFC);
  - (b) Chief Engineer/Construction, Water Supplies Department (CE/C, WSD);
  - (c) Director of Electrical and Mechanical Services (DEMS); and
  - (d) Commissioner of Police (C of P).

#### 10. Public Comment Received During the Statutory Publication Period

On 18.6.2019, the application was published for public inspection. During the first three weeks of the statutory public inspection period, which ended on 9.7.2019, no public comment was received.

## 11. Planning Considerations and Assessments

- 11.1 The subject application is for temporary warehouse for storage of construction materials at the Site zoned "U" on the OZP. The applied use is not in conflict with the planning intention of the "U" zone which is generally intended for open storage use but is designated with this zoning mainly due to concerns of the capacity of Kung Um Road. In this regard, C for T has no adverse comment on the application. Whilst the Site falls within an area zoned "R2(SSF)c", "A" and an area shown as 'Road' on the RODP of YLS promulgated on 8.8.2017, CE/CID, PlanD does not raise objection to the application and PM(W), CEDD has no objection to the proposed temporary use for 3 years. Approval of the application on a temporary basis of 3 years would not jeopardise the long-term development of the area.
- 11.2 The surrounding areas comprise mainly warehouses intermixed with open storage/storage yards, vehicle repair workshops and parking of vehicles, etc. (**Plan A-2**). As such, the development is not incompatible with the surrounding uses in the subject "U" zone.
- 11.3 There is no adverse comment on the application from concerned government departments and there has been no environmental complaint concerning the Site received in the past three years. Furthermore, relevant approval conditions are recommended in paragraph 12.2 to minimise any potential environmental nuisances or to address the technical requirements of other concerned government departments. Any non-compliance with the approval conditions will result in revocation of the planning permission and UD on the Site will be subject to enforcement action by the Planning Authority. Should the planning application be approved, the applicant will also be advised to follow the latest Code of Practice to minimise any potential environmental impact on the surrounding area.
- 11.4 Given that six previous approvals for similar warehouse uses have been granted to the Site and 100 similar applications have been approved in this part of the "U" zone since the promulgation of TPB PG-No. 13E, approval of the current application is in line with the Committee's previous decisions. There were four similar applications in this part of the "U" zone rejected mainly on the grounds, amongst others, that approval of the application with repeated non-compliances would set an undesirable precedent for other similar planning permissions for temporary uses, thus nullifying the statutory planning control system. However, such considerations are not applicable to the current application.
- 11.5 There is no public comment received on the application during the statutory publication period.

#### 12. Planning Department's Views

- 12.1 Based on the assessments made in paragraph 11, the Planning Department considers that the temporary warehouse for storage of construction materials could be tolerated for a period of 3 years.
- 12.2 Should the Committee decide to approve the application, it is suggested that the permission shall be valid on a temporary basis for a period of 3 years until

<u>2.8.2022</u>. The following conditions of approval and advisory clauses are also suggested for Members' reference:

#### Approval conditions

- (a) no operation between 7:00 p.m. and 9:00 a.m., as proposed by the applicant, is allowed on the Site during the planning approval period;
- (b) no operation on Sundays and public holidays, as proposed by the applicant, is allowed on the Site during the planning approval period;
- (c) no repairing, dismantling, spraying, cleaning, other workshop activities and handling of electrical appliances and computer/electronic parts (including cathode-ray tubes), as proposed by the applicant, shall be carried out on the Site at any time during the planning approval period;
- (d) no medium or heavy goods vehicles exceeding 5.5 tonnes, including container tractors/trailers, as defined in the Road Traffic Ordinance are allowed to be parked/stored on or enter/exit the Site, as proposed by the applicant, at any time during the planning approval period;
- (e) no vehicle is allowed to queue back to or reverse onto/from public road at any time during the planning approval period;
- (f) all existing trees within the Site shall be maintained at all times, as proposed by the applicant, during the planning approval period;
- (g) the existing drainage facilities on the Site shall be maintained at all times during the planning approval period;
- (h) the submission of a condition record of the existing drainage facilities on the Site within 3 months from the date of planning approval to the satisfaction of the Director of Drainage Services or of the Town Planning Board by 2.11.2019;
- (i) the submission of a fire service installations proposal within **6** months from the date of planning approval to the satisfaction of the Director of Fire Services or of the Town Planning Board by <u>2.2.2020</u>;
- (j) in relation to (i) above, the implementation of the fire service installations proposal within **9** months from the date of planning approval to the satisfaction of the Director of Fire Services or of the Town Planning Board by 2.5.2020;
- (k) if any of the above planning conditions (a), (b), (c), (d), (e), (f) or (g) is not complied with during the planning approval period, the approval hereby given shall cease to have effect and shall be revoked immediately without further notice; and
- (l) if any of the above planning conditions (h), (i) or (j) is not complied with by the specified date, the approval hereby given shall cease to have effect and shall on the same date be revoked without further notice.

## Advisory clauses

The recommended advisory clauses are at **Appendix IV**.

12.3 There is no strong reason to recommend rejection of the application.

#### 13. <u>Decision Sought</u>

- 13.1 The Committee is invited to consider the application and decide whether to grant or refuse to grant permission.
- 13.2 Should the Committee decide to approve the application, Members are invited to consider the approval condition(s) and advisory clause(s), if any, to be attached to the permission, and the period of which the permission should be valid on a temporary basis.
- 13.3 Alternatively, should the Committee decide to reject the application, Members are invited to advise what reason(s) for rejection should be given to the applicant.
