1. The application site is subject to a previous planning permission No. A/HSK/313 approved for use exactly the same as the applied use of the current application.
2. The application site is adjoining two sites with two planning permissions for storage of food provision (TPB Ref.: A/HSK/282 & 296) so that it is found compatible with the surrounding environment.
3. The application site will be resumed by Government within 3 years.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including open storage use and warehouse activities.
6. Similar warehouse have been approved within the same "O" zoning. Preferential consideration should be given to the current application.
7. No open storage use will be carried out at the application site.
8. The planning circumstance pertaining to the application site is similar to the recent approval of adjacent open storage yards and port back-up uses.
9. Minimal traffic impact.
10. Insignificant environmental and noise impacts because the applied use is closed in sensitive hours.
11. Insignificant drainage impact because surface U-channel will be provided at the application site.
12. The proposed development is not a new development on green site. The proposed development does not involve the erection of new structures. The applied use will be accommodated in the existing structures.
13. Only light goods vehicle will access the site. No medium and heavy goods vehicle exceeding 5.5 tonnes including container trailer/tractor will access the application site.
14. The spare parts being stored at the application site includes spare parts for fan and air-conditioning. The recyclable materials being stored at the application site includes metal only such as cans and scrap metal.
