1. 申請人 90 年代於附近開始營運貨櫃場，供貨櫃儲存空間給予商業機構或學校儲存辦公室物資等。
2. 由於貨櫃空間供應不足，申請人需要擴充場地以滿足需求。
3. 根據城市規劃條例第 16 條（TPB PG-No. 13G）指引，申請用地被列為“第 2 類地區”即露天倉庫及港口後備用途，如果政府／部門沒有反對，城規會將會從寬考慮。
4. 申請位置遠離民居，有關發展與週邊環境相適應及協調，附近一帶普遍都被批准作為臨時露天倉庫用途，是理想的倉庫位置。
5. 申請人認為就此地段向城規會申請臨時存放用途不會對附近環境、空氣、排水、交通及景觀等等造成不良影響。
6. 擬議項目設置雨水收集方案對排水影響不大，見附圖排水方案。
7. 相關填土只是臨時性質，如有關申請到期或被終止，申請人會回復及美化有關的土地為原來的農業地帶。
8. 申請地點的出入路段有足夠的流通空間及緩衝區，可避免引起交通擠塞問題(見附圖)。
9. 日常噪音對環境影響較小，特別是晚上時段不進行作業。
10. 有關的貨櫃儲存不包括危險品，易燃物品或化學物品，貨物由客戶預約入倉，根據需求預約提取。
11. 附近有類似批准 的露天倉庫個案，例如 A/NE-HLH/61 、A/NE-HLH/70 等。
12. 擬議發展項目為臨時性質將不會影響長遠的規劃發展，懇請城規會從寬處理本次的申請。
