Application supported by Environment and Ecology Bureau (EEB) As the Mainland has officially ratified Kigali Amendment in June 2022, Hong Kong must abide by the amendment to reduce the use of Hydrofluorocarbons (HFCs) refrigerants. With limited import quota, the only solution is to reclaim and reuse the HFCs refrigerants. As there is no refrigerant reclamation plant in Hong Kong, a new development of refrigerant reclamation plant is necessary to operate the process of reclaiming used refrigerants. Meetings and detailed discussion about the establishment and operation of plant in between EEB and Hey Hey Firm Limited (Hey Hey) were executed in the past few months. After consideration, Hey Hey is going to establish and operate a new refrigerant reclamation plant. The land will be
obtained by the application of renting vacant government
land. Hey Hey has the support of this application from EEB.
