**7. Justifications 理由**

The applicant is invited to provide justifications in support of the application. Use separate sheets if necessary. 現請申請人提供申請理由及支持其申請的資料。如有需要，請另頁說明。

The current application aims to seek planning permission from the Town Planning Board (the Board) for Temporary Private Car Park for a Period of 3 Years at the Site.

The Site falls within an area zoned "Village Type Development" ("V") on the approved Lam Tsuen Outline Zoning Plan (OZP) No. S/NE-LT/11. According to the Notes for "V" zone on the OZP, 'Public Vehicle Park (excluding container vehicle)' is a Column 2 use which requires planning permission from the Board. The covering Notes of the OZP stipulates that temporary use or development of any land or building not exceeding a period of 3 years requires permission from the Board.

The Site is accessible via She Shan Road, with an ingress/egress point (about 6m) located at the southeastern boundary of the Site. As shown on the proposed layout plan, the temporary private car park will provide 20 private car parking spaces (5m x 2.5m). There is a one-storey structure (about 35 sqm, not exceeding 3m in height) proposed on the Site for storeroom. The Site will operate 24 hours everyday.

The proposed private car park, which mainly serves the villagers in She Shan Tsuen and in support of the village development, is generally in line with the planning intention of the "V" zone. As such, approval of the application on a temporary basis for a period of three years accords with the long-term planning intention of the "V" zone.

The Site is situated in the village cluster of She Shan Tsuen, making it an ideal location to cater the proposed use and address the parking needs of the villagers. The Site also provides a convenient and safe environment for parking, which is particularly beneficial for the villagers, especially the elderly.

The surrounding areas of the Site are predominately rural in character with a mix of village houses and vegetated areas. The proposed use is considered not incompatible with the surrounding areas. Given the nature and small scale of the proposed development, no adverse traffic, environmental, drainage or infrastructural impacts are anticipated.

There are other approved applications for private car/vehicle park (No. A/NE-LT/628, 632, 671, 695, 696, 702, 730 and 764) in the vicinity of the Site, which are located in nearby "V" zones on the same OZP. In view of the above, approving the current application would not establish an undesirable precedent for other similar applications


