但是公眾泊車位只有15個,停泊車輛場地需求非常急切。 社山路是一條單線雙程行車的道路,
平時路旁的避車處和行人路上泊滿車輛,村民往來大埔市區步行進出社山路都被逼走在車路上,
人車爭路驚險事故常有發生,尤其在晚上情況更為嚴重, 曾經有消防車、救護車及大型車輛
入到村內,因為車輛阻塞通道,而無法掉頭行走。
為避免車輛泊滿在社山路旁避車處和行人路上阻塞交通,減少人車爭路意外,所以社山村應從
村民的請求,在社山村"鄉村式發展區 (Village-Type Development Zone)"範圍內已荒置
的土地,申請作為社山村的臨時停泊車輛場地用途,以抒緩停泊車位嚴重缺乏的問題。
