CLP has received an application for the provision of new electricity supply for LOT1139 RP DD220, intended for chinese medicine reserch center purposes near Pak Kong Road. To enhance the supply network to Pak Kong Road, it is necessary to lay underground cables and install wood poles to connect to the existing electrical network.

Given that the proposed pole installation is located within the CA Zone, there are no feasible alternatives for the proposed works other than installing new poles in this zone. The laying of new underground cables and the installation of poles in the area will have minimal impact on the existing landscape of the Conservation area. There will be no visual impact after the completion of the pole erection works.

In conclusion, this method represents the best approach with the least environmental impact for this application.
