- 1. The application site is on Lots 432 (Part), 433 (Part), 434 (Part), 435 S.A, 435 RP and 2073 in D.D. 106 and Adjoining Government Land, Yuen Long, New Territories.
- 2. The site area is about 16,407 m² which includes 16,155 m² of private land and 252 m² of Government Land.
- 3. The site falls within "Agriculture" ("AGR") on the Approved Kam Tin South Outline Zoning Plan No. S/YL-KTS/15.
