1. The current application is a new application although the site has been storing sand, bricks and gravel with 6 previous planning permissions approved for storage of construction materials.
2. The application site subjects to six previous planning permissions since 2006.
3. The proposed development would not jeopardize the planning intention of "R(E)" zone because the proposed development is temporary in nature.
4. All the planning conditions imposed to the last planning permission have been complied with.
5. The operation hours of the proposed development is 9:00a.m. to 6:00p.m. from Mondays to Saturdays. No operation will be held on Sundays and public holidays.
6. The proposed development is compatible with the surrounding environment.
7. The applicant has complied with all the planning conditions imposed to the last planning permission so that he should be rewarded with another three years planning permission.
8. Shortage of land for port back-up purpose in Lau Fau Shan.
9. Minimal traffic impact.
10. Insignificant environmental and noise impacts because the no operation will be held during sensitive hours.
11. Insignificant drainage impact because surface U-channel has been provided at the application site.
12. No repairing, cleansing, dismantling and workshop activity would be allowed on the application site.
