1. The applicant has occupied a storage yard at Tong Yan San Tsuen in D.D.121 and it has been resumed by Government for New Town Development. The applicant wishes to relocate his business to the application site so as to support his living.
2. The proposed development is temporary in nature and it would not jeopardize the planning intention of “AGR” zone in the long run.
3. The nature, layout, form and scale of the proposed development is not incompatible with the surrounding environment.
4. Similar precedence for warehouses were approved in “AGR” zone for relocation purpose.
5. Minimal traffic impact as shown in the attached estimated traffic generation.
6. Insignificant environmental impact because no operation will be held between 7:00p.m. to 9:00a.m. The warehouse will also be housed within an enclosed structure.
7. Insignificant drainage impact as drainage proposal has been submitted in support of the application.
8. The applicant will comply with planning conditions if the Town Planning Board see fits.
9. The applicant will follow the relevant mitigation measures and requirements as shown in the revised “Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites”.
10. The applicant has contacted Development Bureau for the proposed relocation of his business from Tong Yan San Tsuen to the application site and preliminary comments were received and addressed in the current application. .
11. The construction materials to be stored at the application site includes metal products and sanitary ware and alike.
