A good number of open storage yards and warehouses were found in the 'Government, Institution or Community (1)' zone. The approval of current application would curb the situation. The proposed development is static in nature. It would not generate adverse impact to the surrounding environment. The proposed development is a column 2 use in 'G/IC(1)' zone.
6. Only 2 private cars and a light goods vehicle will access the application site. No medium goods vehicle and heavy goods vehicle will access the site.
