 The applicant wishes to regularize the proposed development so that they submit the current application for the consideration of the Town Planning Board. The application site is currently occupied for warehouse use. Tiles were found within the warehouse.
3. The proposed development conforms to the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses (TPB PG-NO. 13G) because it is situated within Yuen Long South Development Stages 1 & 2. Sympathetic consideration may be given until the site is required for the implementation of the Yuen Long South Development Stages 1 and 2. The application site is zoned 'Category 1' according to Guideline 13G. 4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning. 5. The proposed development is not incompatible with the surrounding environment including open storage use and port back-up activities. 6. Open storage & port back-up uses adjoining the application site were granted with planning permission. Similar preferential treatment should be granted to the current application.
7. The application site is adjoining other warehouses in the vicinity and it is not the first of its kind in the area.
8. Shortage of land for port back-up purpose in Tong Yan San Tsuen.
 The planning circumstance pertaining to the application site is similar to the recent approval of adjacent open storage yards and port back-up uses. Minimal traffic impact.
11. Insignificant environmental and noise impacts because the applied use is housed within an enclosed structure.
12. Insignificant drainage impact because surface U-channel has been provided at the application site.
13. No workshop activity is proposed at the application site.
14. No vehicle exceeding 5.5 tonnes including medium goods vehicle, heavy gods vehicle and container trailer/tractor will access the application site. 15. The operation hours of the proposed development is 9:00a.m. to 5:00p.m. from Mondays to Saturdays. No operation will be held on Sundays and public holidays.
