1. The application site is now being occupied for a warehouse for storage of construction materials. As such, a fresh planning application is submitted for the consideration of the Town Planning Board. 2. The application site is subject to four previous planning permissions but all of them were approved for open storage use. The application site is subject to a previous planning permission No. A/YL-TYST/1108 of which the applicant has complied with all the planning permissions imposed to the last planning permission.
 The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning. The proposed development is not incompatible with the surrounding environment including open storage use and warehouse use. Open storage & warehouse uses adjoining the application site were granted with planning permission. Similar preferential treatment should be granted to the current application. The planning circumstance pertaining to the application site is similar to the recent approval of adjacent open storage yards and warehouse uses.
8. No repairing, dismantling, cleaning or other workshop activities is proposed within the application site. 9. No medium or heavy goods vehicles exceeding 5.5 tonnes, including container tractors/trailers, as defined in the Road Traffic Ordinance will access the application site. 10. Minimal traffic impact.
11. Insignificant environmental and noise impacts because the applied use is housed within enclosed structures and no operation will be held during sensitive hours. 12. Insignificant drainage impact.
13. Shortage of land for port back-up purpose in Tong Yan San Tsuen.
14. The construction materials to be stored at the application site include tiles, wooden molds for making surface channels and alike.
