大綱編號S/TM/40 所規劃的A1地盤面積空間細小，鄰近多達31座樓宇，超過8000個住宅單位的居住人口。使A1土地計劃興建的屋苑過於密。假設日後建成後的樓宇，定會對附近居民造成嚴重滋擾，所以我們與海典軒和豐景園的居民相討後，堅決反對A1土地上興建房屋私的計劃。

因此，如果必須在附近考慮興建房屋，我們建議政府改在附近的恆貴街遊樂場、足球場、籃球場興建樓宇，是更為合適的方案。恆貴街遊樂場、足球場、籃球場有更大的面積空間建造樓宇，單位容量比A1地盤更加大。相較A1地盤恆貴街遊樂場、足球場、籃球場更為符合空間利益。而且、恆貴街遊樂場、足球場、籃球場與附近民居有一定距離，以恆貴街遊樂場、足球場、籃球場替代A1地盤能減少對附近多達8000個住宅單位的居民的影響，避免樓宇之間的過分密集地盤讓樓宇之間保持適當健康的距離房屋。

至於A1地盤，我們認為可以充分利用其土地打造小型休閒空間或綠化空間。A1地盤面積細小，不能有效解決房屋需求問題。適逢現時屯門泳池位置將來計劃擬建十數棟住宅樓宇，把A1地盤打造小型休閒空間或綠化空間將提升周圍環境的美觀度，甚至進一步滿足社區的需求。

若果真的考慮於恆貴街遊樂場、足球場、籃球場上興建房屋，球場則可考慮搬到在A1地盤建設，保持當區的運動休憩社區設施。

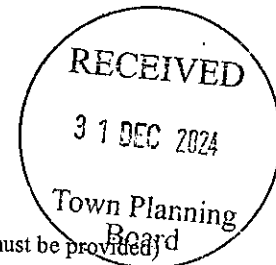

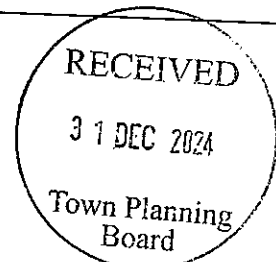

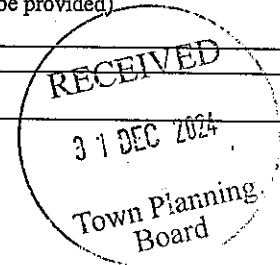
