### **TOWN PLANNING ORDINANCE (Chapter 131)**

# AMENDMENTS TO THE APPROVED NAM SANG WAI OUTLINE ZONING PLAN NO. S/YL-NSW/8

Pursuant to section 12(1)(b)(ii) of the Town Planning Ordinance (as in force immediately before the commencement of the Development (Town Planning, Lands and Works) (Miscellaneous Amendments) Ordinance 2023 (25 of 2023) (the Amendment Ordinance)), the Chief Executive in Council (CE in C) on 28 March 2023 referred the approved Nam Sang Wai Outline Zoning Plan (OZP) No. S/YL-NSW/8 (the Plan) to the Town Planning Board (the Board) for amendment.

The Board has made amendments to the Plan. The amendments are set out in the Schedule of Amendments. The descriptions of the areas affected by the amendments in the Schedule of Amendments are for general reference only. The exact locations of the areas affected by the amendments are more specifically shown on the draft Nam Sang Wai OZP No. S/YL-NSW/9.

The draft Nam Sang Wai OZP No. S/YL-NSW/9 showing the amendments is exhibited under section 5 of the Town Planning Ordinance as amended by the Amendment Ordinance (the Ordinance) for public inspection for a period of two months from 12 July 2024 to 12 September 2024 during normal office hours at the following locations:-

- (i) the Secretariat of the Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (ii) the Planning Enquiry Counter, 17th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (iii) the Planning Enquiry Counter, 14th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories;
- (iv) the Fanling, Sheung Shui and Yuen Long East District Planning Office, Planning Department, Unit 2202, 22/F, CDW Building, 388 Castle Peak Road, Tsuen Wan, New Territories:
- (v) the Yuen Long District Office, Yuen Long District Office Building, 269 Castle Peak Road, Yuen Long, New Territories;
- (vi) the San Tin Rural Committee, 7 Main Road, San Tin, Yuen Long, New Territories; and
- (vii) the Shap Pat Heung Rural Committee, 1 Yau Tin East Road, Yuen Long, New Territories.

In accordance with section 6(1) of the Ordinance, any person may make representation to the Board in respect of any of the amendments. The representation should be made in writing to the Secretary, Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong not later than 12 September 2024.

In accordance with section 6(2) of the Ordinance, a representation shall indicate:-

(a) the particular matter in any of the amendments to which the representation relates;

- (b) the nature of and reasons for the representation; and
- (c) the amendments (if any) proposed to the plan.

Any representation made to the Board will be available for public inspection under section 6(4) of the Ordinance until the CE in C has made a decision in respect of the plan or the part or parts of the plan to which the representation relates under section 9 of the Ordinance.

Any person who intends to make representation is advised to read the Town Planning Board Guidelines on "Submission and Processing of Representations and Further Representations under the Town Planning Ordinance" (the Guidelines). Submission of representation should comply with the requirements set out in the Guidelines. In particular, if the representer fails to provide full name and the first four alphanumeric characters of HKID card/passport number as required under the Guidelines, the representation submitted may be treated as not having been made. The Secretariat of the Board reserves the right to require the representer to provide identity proof for verification. The Guidelines and the submission form are available at locations (i) to (iii) above and the Board's website (<a href="http://www.tpb.gov.hk/">http://www.tpb.gov.hk/</a>).

## Statement on Personal Data

The personal data submitted to the Board in any representation will be used by the Secretary of the Board and government departments for the following purposes:

- (a) the verification of identity of the person making the representation (hereafter known as "representer") and the authorized agent;
- (b) the processing of the representation which includes making available the name of the "representer" for public inspection when making available the representation for public inspection; and
- (c) facilitating communication between the "representer" and the Secretary of the Board/government departments

in accordance with the provisions of the Ordinance and the relevant Town Planning Board Guidelines.

# SCHEDULE OF AMENDMENTS TO THE APPROVED NAM SANG WAI OUTLINE ZONING PLAN NO. S/YL-NSW/8 MADE BY THE TOWN PLANNING BOARD UNDER THE TOWN PLANNING ORDINANCE (Chapter 131)

### I. Amendments to Matters shown on the Plan

- Item A1 Rezoning of a site to the north of Ho Chau Road from "Residential (Group D)" ("R(D)") to "Residential (Group A)1" with stipulation of building height restriction.
- Item A2 Rezoning of a site to the north of Ho Chau Road from "R(D)" to "Residential (Group A)2" with stipulation of building height restriction.
- Item B Rezoning of a site to the north of Ho Chau Road from "R(D)" to "Other Specified Uses" ("OU") annotated "Pumping Station".
- Item C Rezoning of a strip of land to the north of Ho Chau Road from "R(D)" to "Village Type Development" ("V").
- Item D Rezoning of a knoll to the north of Ho Chau Road from "R(D)" to "Green Belt".
- Item E Rezoning of a site at Wing Kei Tsuen from "OU" annotated "Comprehensive Development to Include Wetland Restoration Area" ("OU(CDWRA)") to "OU" annotated "Comprehensive Development to Include Wetland Restoration Area 1" ("OU(CDWRA)1") with stipulation of building height restriction.

### II. Amendments to the Notes of the Plan

- (a) Incorporation of a new set of Notes for "Residential (Group A)" zone with development restrictions.
- (b) Deletion of 'Market' from Column 2 of the Notes for "R(D)" and "V" zones.
- (c) Incorporation of 'Government Refuse Collection Point' and 'Public Convenience' under Column 1 of the Notes for "V" zone; and corresponding deletion of 'Government Refuse Collection Point' and 'Public Convenience' under Column 2 of the Notes for "V" zone.
- (d) Incorporation of 'Field Study/Education/Visitor Centre' and 'Hotel (Holiday House only)' under Column 2 of the Notes for "V" zone.
- (e) Revision of 'Shop and Services' to 'Shop and Services (not elsewhere specified)' under Column 2 of the Notes for "Government, Institution or Community" ("G/IC") zone.
- (f) Incorporation of 'Zoo' under Column 2 of the Notes for "G/IC" zone.

- (g) Revision to Notes for "G/IC" and "OU" annotated "Comprehensive Development and Wetland Enhancement Area" ("OU(CDWEA)") zones on planning intention.
- (h) Revision to the Remarks of the Notes for "OU(CDWEA)", "OU(CDWRA)" and "Conservation Area" zones on filling of land/pond and excavation of land clause in accordance with the Master Schedule of Notes to Statutory Plans.
- (i) Revision to the Remarks of the Notes for "OU(CDWRA)" zone to incorporate development restrictions for "OU(CDWRA)1" sub-zone.
